Agricultural prices 1999/2000: wine, common organisation of the market COM (amend. regul. 822/87/EEC)

Prices for agricultural products - Wine (common market organisation): Pending the decision on the reform of the common market organisation for the wine sector, which will come into force on the 01/08/2000, the Commission proposes amending the basic Regulation 822/87/EEC to provide for the extension of certain related measures and derogations (which would otherwise expire), namely: - the possibility for the Commission to adopt the measures, if necessary, in order effectively to apply compulsory distillation; - the derogation for Greece for a specific application of the regime for compulsory distillation; - the flexibility (introduced in 1996) available to Member States for adjusting (by way of replacement measures) the contributions of sub-regions to the regional allocation of quantities for compulsory distillation; - the possibility for Spain to continue blending red and white wine (mezcla); - the possibility of withholding part of the aid for must used for the production of grape juice, with a view to the promotion of grape juice; - the derogation relating to the total acidity content of table wines.?

Agricultural prices 1999/2000: wine, common organisation of the market COM (amend. regul. 822/87/EEC)

PURPOSE: Agricultural prices 1999/2000 - Wine (common organisation of the market). COMMUNITY MEASURE: Council Regulation 1677/1999/EC. CONTENT: The Council has introduced an amendment to Regulation 822/87/EC which provides that Member States may grant authorisation for new planting as from 1 January 2000 until the end of the 1999/2000 wine year by using up to 20% of the planting rights newly created which are allocated to them in Regulation 1493/1999/EC on the common organisation of the wine market, approved in the context of Agenda 2000. These rights may only be used subject to compliance with the provisions laid down in Title II, Chapter I of that Regulation. Furthermore, pending application of the reform of the sector and in order to avoid any legal hiatus, certain provisions of Regulation 822/87/EEC are extended for a further wine year (e.g. the possibility for Spain to continue to blend red and white wine (mezcla); possibility to

withhold part of the aid for must used in the production of grape juice with a view to the promotion of grape juice; the derogation relating to the total acidity content of table wines. ENTRY INTO FORCE: 30.07.1999. It shall apply from 1 September 1999?
