Agricultural prices 1999/2000: sparkling wines and liqueur wines (amend. regul. 2332/92/CEE, 4252/88/EEC)

Prices for agricultural products 1999/2000 - liqueur wines and sparkling wines): Pending the decision on the reform of the common market organisation for the wine sector, which will come into force on the 01/08/2000, the Commission proposes the extension by one marketing year of certain related measures and derogations and notably the requirement to present a report on the sulphur dioxide content of wines, sparkling wines and liqueur wines to be accompanied, where appropriate with proposals.?

Under consultation procedure, the European Parliament approved the Commission proposal for a Council regulation amending regulation 2332/92/EEC as regards sparkling wines produced in the Community and regulation 4252/88/EEC on the preparation and marketing of liqueur wines produced in the Community.?

PURPOSE: Agricultural prices 1999/2000 - liqueur wines COMMUNITY MEASURE: Council Regulation 1678/1999/EC amending Regulation 2332/92/EEC as regards sparkling wines produced in the Community and Regulation 4252/88/EEC on the preparation and marketing of liqueur wines produced in the Community. CONTENT: pending the application of the reform of the common organisation of the wine sector, the Council has decided to extend certain measures and derogations relating to the marketing of sparkling wines and of liqueur wines. The Commission was required to present a report to the Council on the maximum sulphur dioxide content of sparkling wines and liqueur wines by 1 April 1999 together, where appropriate, with proposals. ENTRY INTO FORCE: 30.07.1999.?
