## Agricultural prices 1999/2000: permanent abandonment premiums for wine-growing areas (amend. regul. 1442/88/EEC)

Prices for agricultural products 1999/2000 - Wine (permanent abandonment of wine-growing areas): Pending the decision on the reform of the common market organisation for the wine sector, which will come into force on 01/08/2000, the Commission proposes the extension by one marketing year of the arrangements for permanent vineyard abandonment measures (Regulation 1442/88/EEC).?

## Agricultural prices 1999/2000: permanent abandonment premiums for wine-growing areas (amend. regul. 1442/88/EEC)

Under consultation procedure, the European Parliament approved the Commission proposal for a Council regulation amending regulation 1442/88/EEC on the granting, for the 1988/89 to 1998/99 wine years, of permanent abandonment premiums in respect of wine-growing areas, subject to an amendment in the following area: - providing that applications for premiums must be submitted before 31/03 of each wine year to the departments appointed by the Member States and that, where applications relate to cultivated wine-growing areas under wine-grape varieties, they shall be supplemented by an official declaration stating the yield per hectare.?

## Agricultural prices 1999/2000: permanent abandonment premiums for wine-growing areas (amend. regul. 1442/88/EEC)

PURPOSE: Agricultural prices 1999/2000 - Wine (permanent abandonment premiums in respect of wine-growing areas). COMMUNITY MEASURE: Council Regulation 1679/99/EC. CONTENT: pending application of the reform of the common organisation of the market in wine, the Council has decided to extend the existing scheme for the grant of permanent abandonment premiums in respect of wine-growing areas. In order to maximise the use of this measure, applications for premiums must be submitted before 31 March of each year to the departments appointed by the Member States. ENTRY INTO FORCE: 30.07.1999.?
