Agricultural prices 1999/2000: white and raw sugar, A and B beet, compensation storage costs (Regulation /EEC) No 1785/81)

Prices for agricultural products 1999/2000 - Sugar: The Commission proposes a freeze on the basic price for beet, the intervention price for white sugar and the manufacturing margin. As a consequence, the price proposals for sugar for the 1999/2000 marketing year are as folows: - basic price for beet: 47.67 EUR/t - minimum price for A beet: 46.72 EUR/t - minimum price for B beet: 32.42 EUR/t - intervention price for white sugar: 63.19 EUR/q - target price for white sugar: 66.50 EUR/q - intervention price for raw sugar: 52.37 EUR/q The minimum prices for A beet and B beet are unchanged (they are derived from the basic price for beet by application of a levy of 2% and 30% respectively). However, it must be noted that the actual minimum price for B beet will depend ultimately on the final rate of the levy on B beet to be fixed later by the Management Committee procedure (in accordance with Article 28 of Regulation 1785/81/EEC). For Italy, the latest available statistics indicate that this Member State is not a deficit area and consequently no derived intervention price for white sugar is proposed. As far as the reimbursement of storage costs is concerned, the Commission proposes that the amount of the monthly refund should be reduced from EUR 0.38 to EUR 0.33 per 100 kg, in view of the lower interest rates prevailing in the Community.?

Agricultural prices 1999/2000: white and raw sugar, A and B beet, compensation storage costs (Regulation /EEC) No 1785/81)

The Committee approved the Commission's proposed farm prices for 1999/2000 virtually unchanged after voting down all but two of the rapporteur's amendments seeking higher prices to offset income losses suffered by farmers. Mr Happart had wanted a 3.8% increase in farm prices in 1999/2000 to make up for the decline in real terms in farmers' incomes in 1998 caused by the EU's average inflation rate of 1.9% and the fall in prices - also put at 1.9% - resulting from the abolition of the green ecu and the transition to the euro. The Commission's price package, which pursues the policy of stability introduced with the 1992 McSharry reform, actually reduces the EU farm budget by ·1.4 billion from the 1998 level. ?

Under consultation procedure, the European Parliament approved the Commission proposal for a Council regulation fixing the derived intervention prices for white sugar, the intervention price for raw sugar, the minimum prices for A and B beet and the amount of compensation for storage costs for the 1999/2000 marketing year.?

PURPOSE: Agricultural prices 1999/2000 - Sugar (the derived- intervention prices for white sugar, the intervention price for raw sugar, the minimum proces for A and B beet, and the amount of compensation for storage costs). COMMUNITY MEASURE: Council Regulation 1404/1999/EC. CONTENT: the Council has decided to freeze the basic price of beet, the intervention price for white sugar and the production margin. As a consequence, the prices of sugar for the 1999/2000 marketing year will be as follows: - 64.65 EUR/100 kg. for all the areas in Ireland and the UK; - 64.65 EUR/100 kg. for all the areas in Portugal; - 64.65 EUR/100 kg. for all the areas in Finland; - 64.88 EUR/100 kg. for all the areas in Spain; - Intervention price of raw sugar: EUR 52.37 EUR/100 kg; - Minimum price for A beet: 46.72 EUR/tonne; - Minimum price for B beet: 32.42 EUR/tonne. The amount for the reimbursement of storage costs will be EUR 0.33 per month per 100 kg of white sugar. ENTRY INTO FORCE: 30.06.1999. The Regulation shall apply for the 1999/2000 marketing year.?
