1988/1989 to 1998/1999 wine years: permanent abandonment premiums (amend. Regulation (EEC) No 1442/88)

PURPOSE: to prolong for 3 months the deadline of 31/12/98 for applications for permanent abandonment premiums for wine-growing areas in the Charentes region of France. CONTENT: this proposed regulation is designed to facilitate the application of the Community regime for abandonment of wine-growing areas in the specific case of the French region of Charentes which is currently facing a serious crisis of overproduction (cognac). This dispensation has also been applied across the Member States for the wine-growing seasons of 1996/97 and 1997/98.?

Under consultation procedure without report, the European Parliament approved the proposal for a Council regulation amending regulation 1442/88/EEC on the granting, for the 1988/89 to 1998/99 wine years, of permanent abandonment premiums in respect of wine-growing areas.?

1988/1989 to 1998/1999 wine years: permanent abandonment premiums (amend. Regulation (EEC) No 1442/88)

PURPOSE: amendment to set a new deadline for the submission of application for the permanent abandonment scheme so as to facilitate the maximum use of that scheme throughout the Cognac production region. COMMUNITY MEASURE: Council Regulation 859/1999/EC amending Regulation 1442/88/EEC on the granting, for the 1988/89 to 1998/99 wine years, of permanent abandonment premiums in respect of wine-growing areas. CONTENT: Pending the adoption of the reformed organisation of the market in wine, and as a result of the over-production crisis throughout the Cognac production area, new deadlines are set for the submission of applications for the permanent abandonement premium so as to facilitate maximum use of that scheme in the above region, while maintaining the last date for grubbing up. For the 1998/1999 wine year for the Charentes region, the last date for the submission of applications for the premium shall be 31 March 1999 and the last date for grubbing up shall be 15 May 1999. ENTRY INTO FORCE: 27.04.1999.?
