Interinstitutional Agreement on internal investigations by the European Anti-fraud Office (OLAF)

PURPOSE: draft interinstitutional agreement regarding investigations undertaken by the Office for the fight against fraud. CONTENT: this draft interinstitutional agreement proposes the adoption of a common regime to allow the Office for the fight against fraud to carry out investigations inside every institution. This regime will include the necessary execution measures to allow good implementation of internal investigations. In the expectation of the statute's amendment, these execution measures will deal notably with the rights and obligations of administrators and other officials, in full respect of the principles relative to human rights and the protection of fundamental freedoms, during the implementation of investigations inside the institution in question.?

Interinstitutional Agreement on internal investigations by the European Anti-fraud Office (OLAF)

The European Parliament approved the resolution by Herbert Bösch (PSE,AT), which approves the draft interinstitutional agreement concerning internal investigations by the European Fraud Prevention Office (OLAF). The rapporteur welcomed the fact that all officials are obliged to inform their superiors or OLAF of anything which could be suspected of implicating fraud. Mr. Bösch was also concerned that the Office should be up and running as soon as possible and hopefully before the end of the year.?
