EEA agreement: amending annex IV (energy, electricity)

PURPOSE: amendment of Annex IV (Energy) to the EEA in order to integrate all the relevant Community legislation into the EEA Agreement as soon as possible after its adoption. CONTENT: In order to ensure the requisite legal security and homogeneity, the EEA Joint Committee is to integrate all the relevant Community legislation into the EEA Agreement as soon as possible after its adoption. Council Regulation No. 2894/94 concerning arrangements for implementing the EEA Agreement envisages that the Council, following consultation with the European Parliament, should establish the Community position for decisions covering Community legislation involving important modifications. This proposed decion seeks to amend Annex IV of the EEA Agreement with the purpose of incorporating within it European Parliament and Council Directive 96/62/EC concerning common rules for the internal market in electricity (with some small adaptations to the Community text).?

The EEA Joint Committee adopted Decision 168/1999 amending Annex IV (Energy) to the EEA Agreement in order to incorporate the Community acquis recently adopted in this field and to include Directive 96/92/EC concerning common rules for the internal market in electricity (with some amendments as regards the Community text), specifying that, for the purposes of the Agreement, the share of the national market referred to in Article 19(1) and (2) of Directive 96/92/EC was to be based on the calculation of the average Community share of electricity market opening.?
