Supplementary and amending budget 2/1999: section II Council

PURPOSE: Presentation of a draft supplementary and amending budget for the year 1999 concerning the Council. CONTENT: In accordance with the financial regulation, the Commission is proposing to the budgetary authority a draft supplementary and amending budget no. 2 for 1999 concerning the section 2 of the Communities budget, relating to the Council. The objective of this supplementary and amending budget is to permit the introduction of a support structure for the High Representative for the High Representative for Common Foreign and Security Policy. In particular, it provides for new posts for the High Representative himself and his colleagues (11 permanent or temporary official posts, overall).?

Supplementary and amending budget 2/1999: section II Council

On 21.06.1999, the Council adopted the draft supplementary and amending budget 2/99 that concerns it, and confirmed the creation of 11 posts with respect to the High Representative for the CFSP. The creation of these posts does not require any budgetary modification. For this reason, both the expenditure and the revenue sides of the budget remain unchanged.?

Supplementary and amending budget 2/1999: section II Council

Adopting the report by Terence Wynn (PSE,UK), the Parliament recalled that operational expenditure in respect of PESC is recorded in sub-section B8 of section 3. It specified that the 11 new permanent or temporary jobs proposed following the nomination of the Secretary General/High representative are purely a matter of administrative expenditure. As no amendments were made to the draft budget, the Parliament considered that the corrected draft budget had been adopted.?
