Regulation 2000/191 OJ L 023 28.01.2000, p. 0004 Summary

Hops: common organisation of the market CMO (amend. Regulation (EEC) No 1696/71)

PURPOSE: amendment of Regulation 1696/71/EEC concerning the organisation of the common market in the hops sector. CONTENT: The proposed changes to Regulation 1696/71/EEC consist in the deletion of the provisions which are no longer applicable from a time perspective (deadline passed) or from the point of view of content of the OCM in the hops sector. The Member States which produce hops, in fact, no longer have the right - with the exception of Austria - to assistance for the start-up of producer groups, because the deadlines are already past. Furthermore, because the Council set the aid for producers at the same level for 5 years, it is no longer necessary that the Commission each year presents a report to the Council on the situation with regard to the production and the marketing of hops.?

Hops: common organisation of the market CMO (amend. Regulation (EEC) No 1696/71)

The committee unanimously adopted the report (consultation procedure) by Xaver MAYER (EPP/ED, D) endorsing the Commission proposal to delete articles of the regulation which are no longer applicable either because the time limits in question have expired or because the regulation has already been amended. The Commission considered that there was no longer any need to submit an annual report on the production and marketing of hops as the Council had fixed a flat rate of aid for a five-year period. The committee agreed but adopted an amendment ensuring that data is recorded annually and made available on trends, demand, varieties, prices and developments in the sector in view of the difficult conditions on the hop market.

Hops: common organisation of the market CMO (amend. Regulation (EEC) No 1696/71)

By adopting the report by Xaver MAYER (EPP, D), the European Parliament approved the amended proposal on the common organisation of the market in the hops sector. The Parliament calls on the Commission to ensure that all the available data required for assessing the situation on the hops market is recorded, evaluated and made available annually to market operators. Such data shall in particular relate to trends in the area under hops, demand, the distribution of different varieties, prices and developments in hop-growing in individual Member States.?

Hops: common organisation of the market CMO (amend. Regulation (EEC) No 1696/71)

PURPOSE : to amend certain features of Council Regulation 1696/71/EEC on structural assistance aspects relating to the Community hops

market. COMMUNITY MEASURE : Council Regulation 191/2000/EC amending Regulation 1696/71/EEC on the common organisation of the market in hops. CONTENT : the amendment is designed: - to delete from the basic regulation the provision requiring the Commission to submit a report every year, since the rate of aid is now set every five years rather than every year, - to stipulate that a report should be submitted at the end of every five year period. ENTRY INTO FORCE: 01/01/2000.?
