Decision 1999/762 OJ L 301 24.11.1999, p. 0006 Summary

Animal diseases: control of foot-and-mouth disease, reserves of vaccines (amend. Decision 666/91/EEC)

PURPOSE: amendment of Decision 91/666/EEC establishing Community reserves of foot and mouth disease vaccines. CONTENT: The purpose of this proposal is to provide for the legal instruments to designate, as needs arise, additional premises for the storage of Community reserves of inactivated foot and mouth disease antigen by Commission Decision following Standing Veterinary Committee procedures.?

Animal diseases: control of foot-and-mouth disease, reserves of vaccines (amend. Decision 666/91/EEC)

PURPOSE : to amend Decision 91/666/EC establishing Community reserves of foot-and-mouth disease vaccines. COMMUNITY MEASURE : Council Decision 1999/762/EC. CONTENT : in order to allow immediate reaction to the need to distribute or relocate the Community reserves of foot-and-mouth disease antigen for storage at different sites. Directive 91/666/EEC is amended, in particular as regards the procedures laid down for the designation of antigen and vaccine banks.?

The Council was informed by Commissioner BYRNE on protective measures adopted following the cases of foot and mouth disease in the United Kingdom and France, especially those applying to these two countries. The Council also had an exchange of views on vaccination against foot and mouth disease. It noted the Commission's intention to propose a Regulation on foot and mouth disease, which would provide an opportunity to review current policies. ?
