Supplementary and amending budget 3/1999: section IV Court of justice, section VI Committee of the regions

PURPOSE: Proposal of a draft supplementary and amending budget for the year 1999 concerning the Court of Justice and the Committee of the Regions. CONTENT: In accordance with the financial regulation, the Commission is proposing to the budgetary authority a supplementary and amending budget no.3 of 1999 grouping together the requests from the Court of Justice (section IV of the Communities' budget) and the Committee of the Regions (section VI). These requests relate respectively to the installation of new word processing facilities at the Court of Justice (for an additional amount of 1.675.000 Euros) and the creation of three posts to undertake financial control and accounting functions at the Committee of the Regions (for an amount of 64.000 Euros).?
