EC/Angola fisheries agreement: protocol for the period from 3 May 1999 to 2 May 2000

PURPOSE: conclusion of Protocol annexed to the fisheries agreement between the EC and Angola. CONTENT: This proposal for a Council Regulation relates to the conclusion of the Protocol defining, for the period from 3 may 1999 to 2 May 2000, the fishing opportunities and the financial contribution provided for by the Agreement between the EC and the Republic of Angola on fishing off Angola. The Protocol is accompanied by 2 Annexes and several Appendices. Among other things, these cover: - Conditions governing fishing activities in Angolan waters by Community vessels (licence application and issuing formalities, licence fees, biological recovery, by-catches, landings, transhipments, statement of catches, fishing zones, signing of crews, scientific observers, inspection and monitoring, fuel supplies, repairs and other services, mesh sizes and boarding procedure). - Conditions governing the fishing of pelagic species in Angolan waters by Community vessels.?

EC/Angola fisheries agreement: protocol for the period from 3 May 1999 to 2 May 2000

The committee adopted a report by Mr Arlindo CUNHA (EPP/ED, P). Despite the lack of properly detailed information, the shortcomings in the protocol and the uncertainty over the real state of Angolan fish stocks (shrimps and demersal fish), the rapporteur proposed that the outcome of what were apparently difficult negotiations for the Commission be endorsed in view of the fact that the protocol was valid for only a short period of time (it was merely an extension of the existing protocol, with a view either to its renewal or to the drafting of a new type of fisheries agreement) and given the deplorable state of this potentially rich and geo-politically important country.

EC/Angola fisheries agreement: protocol for the period from 3 May 1999 to 2 May 2000

The Parliament adopted its report drafted by Mr. Arlindo Cunha (PES, P). The report contains 3 amendments to the Commission's proposal:

1) in view of the Protocol's short period of validity and the importance of improving the supply of information, the Commission must submit to the European Parliament a report on implementation of this Agreement, with a view to facilitating decision-making on its possible renewal; 2) three months before the Protocol's expiry and prior to the conclusion of any agreement seeking to renew it, the Commission is to submit to the Council and the Parliament a report on the state and conditions of the implementation of the Agreement; 3) on the basis of that report, and

following consultation of the European Parliament, the Council shall give the Commission a mandate to negotiate the implementing protocols to this Agreement.?

EC/Angola fisheries agreement: protocol for the period from 3 May 1999 to 2 May 2000

PURPOSE: to approve the Protocol between the Community and Angola on fishing opportunities and financial compensation. COMMUNITY MEASURE: Council Regulation 103/2000/EC on the conclusion of the Protocol defining, for the period from 3 May 1999 to 2 May 2000, the fishing opportunities and the financial compensation provided for by the Agreement between the European Economic Community and the government of the People's Republic of Angola on the fishing off Angola. CONTENT: - The fishing possibilities provided for in the Protocol are allocated among the Member States; - The financial compensation is set at 10 300 000 EURO; - The Community will contribute 1 700 000 EURO towards the financing of Angolan scientific and technical programmes. Part of this amount may be used to cover Angola-s contributions to international fisheries organisations. - During the life of this Protocol, the Community shall provide EURO 350 000 annually for scientific studies and fishery surveys. - The Community shall provide Angolan nationals with study and practical training grants in the various scientific, technical and economic disciplines relating to fisheries through grants not exceeding 1 000 000 EURO. ENTRY INTO FORCE: 24/01/2000.?
