Europol: establishment of remuneration, pensions and other financial entitlements in euro

PURPOSE : to amend the Council Act laying down the staff regulations applicable to Europol employees, with regard to the establishment of remuneration, pensions and other financial entitlements in euro. CONTENT : the Proposal aims uniquely at amending the Council Act of 3 December 1998 by replacing the terms "Dutch guilders" and "NGL" with "euro" and "EUR" respectively, and amounts expressed in Dutch guilders and NGL shall be replaced by their equivalent in euro units at the conversion rate laid down by the Council.?

CONTENT : the Decision aims uniquely at amending Council act of 03.12.1998 laying down the staff regulation applicable to Europol employees so that all the different financial entitlements mentioned in this act be expressed in euro whereas before they were expressed in Dutch guilders which is the currency of the State in which the EUROPOL headquarters are situated. ENTRY INTO FORCE : 03.12.1999.?
