Verification of credentials of members elected for the European elections in June 1999

The committee adopted the report by Mrs Ana PALACIO VALLELERSUNDI (EPP/ED, E) declaring valid the mandates of all Members elected at the last European Elections. It should be noted that this verification of credentials is a technical process which essentially seeks to ensure that elected Members have completed the necessary written declarations to the effect that they do not hold an office incompatible with that of an MEP, and that they have provided information on their professional and financial interests.

In adopting the report by Mrs Ana PALACIO VALLELERSUNDI (EPP/ED, E), the European Parliament declares valid the mandate of the Members of the European Parliament notice of whose election had been forwarded by the competent national authorities. This list also confirms that the elected Members have signed a declaration on the offices which are incompatible with that of Member of the European Parliament and that they provided information on their financial and professional interests. In addition, the Parliament repeats its request to the authorities of the Member States whose task is not only to notify the European Parliament of the names of the elected candidates, but also to forward the names of any substitutes, together with their ranking in accordance with the results of the vote.?
