Excise duty beer imports into Finland: temporary quantitative restrictions (amend. Directives 69/169/EEC, 92/12/EEC)

PURPOSE: to amend Directives 69/169/EEC and 92/12/EEC as regards temporary quantitative restrictions on beer imports into Finland. CONTENT: owing to fiscal, economic, social, health and public order problems, Finland has requested a separate restriction on beer imports from countries other than Member States. The request is due to the increased imports of alcoholic beverages, especially beer, from Russia and Estonia. Therefore, it is proposed that Finland shall be authorised to apply a quantitative limit of not less than 6 litres for the importation of beer from countries other than Member States.?

Excise duty beer imports into Finland: temporary quantitative restrictions (amend. Directives 69/169/EEC, 92/12/EEC)

In its first reading, the European Parliament adopted the resolution drafted by Astrid LULLING (PPE/ED, Luxembourg) amending the proposal for temporary quantitative restrictions on beer imports into Finland. No substantial changes were made, but the recitals were amended to emphasise that the phased elimination of the restrictions will give the Finnish authorities time to put in place alternative means of combating alcohol-related problems. Parliament also stated in its amendments that Finland has fiscal sovereignty to apply excise taxes at a level it deems most appropriate. Whilst the provisions of this proposal do not affect that status, Finland may decide that a reduction of excise differentials with other Member States could help prevent an otherwise likely increase in cross-border shopping levels.?

Excise duty beer imports into Finland: temporary quantitative restrictions (amend. Directives 69/169/EEC, 92/12/EEC)

PURPOSE: to amend Council Directives 69/169/EEC and 92/12/EEC as regards temporary quantitative restrictions on beer imports into Finland. COMMUNITY MEASURE: Council Directive 2000/47/EC amending Directives 69/169/EEC and 92/12/EEC as reagards temporary quantitative restrictions on beer imports into Finland. CONTENT: Finland has requested a derogation to apply a limitation for beer imports from countries other than Member States, or not less than 6 litres. It is appropriate to maintain this derogation two years longer than the restrictions on beer brought to Finland from other Member States, in order to allow the Finnish retail trade to adapt to the new situation. Thus, Directive 69/169/EEC shall be modified so that Finland shall be authorised, until 31 December 2005, to apply a quantitative limit of not less than 6 litres for the importation of beer from countries other than Member States.
