PURPOSE : Council Decision to conclude the Protocol extending the existing Cooperation Agreement between the European Community and the Member Countries of ASEAN to the Kingdom of Cambodia. CONTENT : The Commission negotiated the Protocol on this extension between the European Community and the countries of Brunei-Darussalem, Indonesia, Malaysia, the Philippines, Singapore, Thailand and Viet Nam. The Agreement was initialled on 16 June 2000. The opinion of the European Parliament to the extension of the Agreement to Cambodia is required.?
