Decision 2001/513 OJ L 186 07.07.2001, p. 0004 Summary

Police cooperation: exchange programme for law enforcement authorities of the Member States, Oisín II

PURPOSE: to present a Commission proposal for a Council decision establishing a second phase of the programme of incentives, exchanges, training and cooperation for law enforcement authorities (Oisín II). **CONTENT:** On 31.12.2000, the Oisín programme, one of three multiannual financing programmes adopted through Joint Actions on the basis of Article K.3 of the Treaty on European Union, will expire. Its proposed successor Oisín II will encourage cooperation between the law enforcement services of the Member States to allow them to achieve a better understanding of the working methods of their counterparts in other Member States and constraints by which they may be bound. The applicant countries may participate in projects in order to familiarise themselves with the Union "acquis" in this area and help them prepare for accession. Other third countries may also participate where this serves the aims of the project. The main provisions in the proposed decision relate to access to Oisín II, activities, implementation, monitoring and its evaluation. With regard to finance, the annual appropriations shall be authorised by the budgetary authority within the limits of the financial perspective. Furthermore, the proportion of financial support from the Community budget shall not exceed 70% of the cost of the project. In certain cases however, measures can be financed to 100%, up to a ceiling of 10% of the total financial package allocated annually to the programme for each of the two categories. The financial reference amount for the implementation of the programme for the period 2001 to 2002 shall be EUR 8 million. Finally, with regard to evaluation, the Commission shall undertake each year an evaluation of the actions carried out in implementing the programme for the previous year. Each year, the Commission shall also report to the European Parliament and the Council on the implementation of the programme. The first report shall be presented before 31.07.2002.?

Police cooperation: exchange programme for law enforcement authorities of the Member States, Oisín II

The European Parliament voted to endorse the report by Mrs Margot KESSLER (PES, D) concerning a Commission proposal to establish a second phase for the crime prevention training programme Oisin. However, the Parliament is calling for the incorporation of this programme into a single framework programme which will also include the Grotius and Stop programmes instead of waiting another two years as proposed by the Commission. PURPOSE : to establish a second phase of the programme of incentives, exchanges, training and cooperation for law enforcement authorities (Oisin II). COMMUNITY MEASURE : Council Decision 2001/513/JHA establishing a second phase of the programme of incentives, exchanges, training and cooperation for law enforcement authorities (Oisin II). CONTENT : this Decision establishes the second phase of the Oisin cooperation programme. This programme is hereby renewed for the period from 1 January 2001 to 31 December 2002. The programme shall contribute to the general objective of providing citizens with a high level of protection in the area of freedom, security and justice. Within this framework, it is intended to encourage cooperation between the Member States' law enforcement authorities and to provide such authorities with a greater insight into the working methods of their counterparts in other Member States and constraints by which they may be bound. The applicant countries may participate in projects in order to familiarise themselves with the Union acquis in this area and help them prepare for accession. The programme shall comprise the following types of activities: - training; - exchanges and work experience placements; - studies and research; - meetings and seminars; - dissemination of the results obtained within the framework of the programme. With regard to the financial reference amount for the implementation of this programme, this shall be set at EUR 8 million for the period 2001 to 2002. The Commission shall be responsible for the management and implementation of the programme, in cooperation with the Member States. It shall undertake each year an evaluation of the actions carried out in implementing the programme for the previous year. Moreover, it shall also report each year to the European Parliament and the Council on the implementation of the programme. The first report shall be presented before 31 July 2002. ENTRY INTO FORCE : this Decision shall take effect from 07/07/2001. It shall apply until 31 December 2002.?
