## Nuclear safety, Chernobyl: implementation of the Shelter Fund. 2nd report

PURPOSE: to present a proposal for a Council Decision on a second contribution of the European Community to the European Bank for Reconstruction and Development for the Chernobyl Shelter Fund. CONTENT: the Chernobyl Shelter Fund provides a powerful tool to assist the Ukraine in resolving the safety risks posed by the ruins of the ill-fated Unit 4 of the Chernobyl nuclear power plant. In 1997, the G7 Nuclear Safety Working Group outlined and finalised a plan, designated as the Shelter Implementation Plan (SIP), to identify tasks to be executed over a period of 8-10 years to secure and stabilise the sarcophagus. In November 1997, the European Bank for Reconstruction and Development (ERBD) set up the Chernobyl Shelther Fund (CSF). The first pledge to the Fund was made by the European Commission in 1997. Payments of EUR 50 million and EUR 40.5 million were made in 1999 and 2000. In the new Tacis Regulation covering the period 2000-2006, the support to 'relevant EU supported international initiatives such as the G7/EU initiative on the closure of Chernobyl' is explicitly mentioned as a priority action'. As the rules governing the SIP are not consistent with the rules applicable under the Tacis Regulation, it is necessary to establish a separate legal basis for the Community contribution so as to accomodate the Fund rules, as was the case for Council Decision 98/381/EC, Euratom. Against this background, the objective of the proposal is to solicit a Council decision for the second Community contribution of EUR 100 million pledged at the second pledging conference held in July 2000 in Berlin.?

The committee adopted the report by Kyösti VIRRANKOSKI (ELDR, FIN) approving the proposal under the consultation procedure, subject to just two amendments. It agreed with the Commission that a flexible approach was needed and that there should be a transfer from the main TACIS budget line B7-520 to finance this important action - which could contribute to the environmental safety of the EU - even if this meant circumventing the maximum ratio of funds that could be dedicated for nuclear safety according to the remarks under that line. The committee suggested, however, that if at the end of the financial year it turned out that some of the funds earmarked for nuclear safety in budget lines B7-524 or B7-525 could not be used, the Commission should propose to transfer them to line B7-520 to finance other activities under the main TACIS envelope. The other amendment stipulated that Parliament should be informed of all operations of the Chernobyl Shelter Fund that were financed by the Community. ?

## Nuclear safety, Chernobyl: implementation of the Shelter Fund. 2nd report

PURPOSE: to administer EUR 100 million to the Chernobyl Shelter Fund. COMMUNITY MEASURE: Council Decision 2001/824/EC, Euratom on a further contribution of the European Community to the European Bank for Reconstruction and Development for the Chernobyl Shelter Fund. CONTENT: this Decision stipulates that the Commission of the European Community will make a contribution of EUR 100 million to the Chernobyl Shelter Fund in accordance with Article II, Section 2.02 of the Rules of the Fund. The new contribution will be made up of four annual contributions over the years 2001-2004, subject to necessary authorisations of the budgetary authority. Moreover, the Commission will forward all relevant information to the Court of Auditors and may request from the EBRD supplementary information that the Court of Auditors may wish to obtain concerning those aspects of the operation of the Chernobyl Shelter Fund that relate to the Community's contribution. The Commission shall also ensure that, with respect to the procurement arrangements relating to grants made from resources of the Fund, there is no discrimination between the Member States.?
