EC/Senegal fisheries agreement: periods from 1st May to 31 July 2001 and 1st August to 31 December 2001

PURPOSE: To extend the fishing agreement between the Republic of Senegal and the European Union. CONTENT: The current Protocol to the Fisheries Agreement between the Community and the Republic of Senegal expired on 30 April 2001. Pending the conclusion of the negotiations on the amendments to be made to the Protocol, the two parties have decided to extend the expired Protocol for two consecutive periods of three and five months. These two extensions of the Protocol, setting out the technical and financial conditions governing the fishing activities of Community vessels off the coast of Senegal during the periods 1 May to 31 July 2001 and 1 August to 31 December 2001, were initialled by both parties on 23 April and 1 June 2001. A proposal for a Council decision on the provisional application of the two extensions pending their definitive entry into force is the subject of a separate procedure.?

The committee adopted the report by Pat the Cope GALLAGHER (UEN, IRL) approving the proposal without amendment under the consultation procedure.?

EC/Senegal fisheries agreement: periods from 1st May to 31 July 2001 and 1st August to 31 December 2001

The European Parliament adopted the report by Pat the Cope GALLAGHER (UEN/IRE). As it stands the two parties, through an exchange of letters, have provisionally agreed that Community fisherman will continue fishing activities in Senegalese waters until the end of this year. This covers the two periods - May 2001 to July 2001 and August 2001 to December 2001. However, the Commission wants to extend this protocol, which currently benefits Spain, France, Portugal, Italy and Greece. In exchange for fishing opportunities, the European Community will pay Senegalese Government EUR 1 million per month - at the end of the year.?

EC/Senegal fisheries agreement: periods from 1st May to 31 July 2001 and 1st August to 31 December 2001

PURPOSE : to extend for two consecutive periods the current Protocol establishing the fishing opportunities off the coast of Senegal and also the financial compensation. COMMUNITY MEASURE : Council Regulation 2303/2001/EC on the conclusion of two Agreements in the form of Exchanges of Letters concerning the extension of the Protocol establishing the fishing opportunities and financial compensation provided for in the Agreement between the European Economic Community and the Government of the Republic of Senegal on fishing off the coast of Senegal for the periods 1 May 2001 to 31 July 2001 and 1 August 2001 to 31 December 2001. CONTENT : the European Community and the Republic of Senegal entered into negotiations to determine the amendments or additions to be made to the Agreement between the EEC and Senegal on fishing off the coast of Senegal at the end of the period of the Protocol. During negotiations, the two Parties decided to extend the current Protocol for two consecutive periods of three months and five months, from 1 May 2001 to 31 July 2001 and from 1 August 2001 to 31 December 2001. This extension has been approved on behalf of the Community. ENTRY INTO FORCE : 01/12/2001.?
