Forests: protection against fire, extension to 2002 (amend. Regulation (EEC) No 2158/92)

PURPOSE: To extend Community Regulation on the protection of the Community's forests against fire by one year. CONTENT: The Community Regulation 2158/92/EEC on the protection of forests against fire will expire on 31 December 2001. Under the terms of the Regulation the Commission is expected to draw up drafts for a new Regulation. The Commission is currently working on revisions to the existing Regulation but preparations for the revision are not yet complete and thus the end of year deadline will not be met. The Commission is therefore seeking transitional measure to extend the Regulation for a further year thus enabling the scheme to continue until 2002 by which time the draft Regulation should be completed. This proposal seeks to extend the existing Regulation by one year. The budgetary allocation has been amended accordingly and now reads as EUR 58.75 million for the period 1997-2002.?

Forests: protection against fire, extension to 2002 (amend. Regulation (EEC) No 2158/92)

The committee adopted the report by Encarnación REDONDO JIMÉNEZ (EPP-ED, E) approving the proposal under the codecision procedure (1st reading), subject to two amendments. The first of these corrected the figures for the funding of the scheme in line with the increase allocated to the two budget lines (protection against fire and against atmospheric pollution) in the Community budget for 2002. The second amendment set the deadline of 30 June 2002 for the Commission to submit a proposal for the revision of the Regulation?

The European Parliament, using its procedure without debate, adopted the report drafted by Encarnacion Redondo Jimenez (EPP/ED, Spain) on the protection of the Community's forests against fire. (Please refer to the document dated 19/02/02.) The financial allocation for the implementation of the scheme is EUR 59.9 million for the period 1997 to 2002.?

PURPOSE: to the extend Community Regulation on the protection of the Community's forests against fire by one year. COMMUNITY MEASURE: Regulation 805/2002/EC of the European Parliament and of the Council amending Council Regulation 2158/92/EEC on protection of the Community's forests against fire. CONTENT: the Community Regulation 2158/92/EEC on the protection of forests against fire expired on 31 December 2001. Under the terms of the Regulation the Commission is expected to draw up drafts for a new Regulation. The Commission is currently working on revisions to the existing Regulation but preparations for the revision are not yet complete. The Commission is therefore seeking transitional measure to extend the Regulation for a further year thus enabling the scheme to continue until 2002 by which time the draft Regulation should be completed. This Regulation shall extend the existing Regulation by one year. The scheme shall run for 11 years from 11 January 1992. The financial allocation shall be EUR 59,9 million for the period 1997 to 2002. Annual appropriations shall be authorised by the budgetary authority within the limits of the financial perspective. Before 30 June 2002, the Commission shall submit to the European Parliament and to the Council a report on the application of this Regulation and a proposal for a revision covering in particular the ecological, economic and social aspects (qualitative assessment) and the results of a cost-benefit analysis (quantitative assessment). ENTRY INTO FORCE: 17 May 2002.?
