Decision 2002/622 OJ C 150 22.06.2002, p. 0002 Summary

Europol: adjusting the basic salaries and allowances applicable to staff. Initiative Belgium

PURPOSE : to adjust the basic salaries and allowances applicable to Europol staff. **CONTENT** : the draft Decision, Belgian initiative, intends to adjust the basic salaries and allowances applicable to Europol staff taking into account the review of remuneration of officials of Europol by the Management Board of this institution. To recall, regularly the Management Board takes account of the changes in the cost of living in the Hague (the Netherlands, Europol Headquarters) as well as the changes in salaries in the public service in the Member States and the recruitment needs of Europol. The said review justifies an increase of 5,5% of remuneration for the period between 01.07.2001 and 01.07.2002. A table specifies the amounts of all the basic monthly salaries in all the levels and grades of the public service. ?

The committee adopted the report by Gérard DEPREZ (EPP-ED, B) rejecting the Belgian initiative under the consultation procedure. As the initiative did not make clear what data the Europol Management Board had drawn on in conducting its pay review, the committee felt that Parliament could not approve a proposal for an increase if that proposal was not accompanied by a properly argued justification. It added that the need for a justification was all the greater because the proposed increase of 5.2% was well in excess of the 4.3% increase applicable to EU officials in The Hague. ?

PURPOSE : to increase the salaries and allowances of Europol staff. **COMMUNITY MEASURE** : Council Decision 2002/C 150/O2 adjusting the basic salaries and allowances applicable to Europol staff. **CONTENT** : When reviewing remuneration, the Management Board of Europol

took account in the changes in the cost of living in the Netherlands, as well as of the changes in salaries in the public service in the Member States and the recruitment needs of Europol.
