Commission, implementing powers: adapting provisions relating to committees, consultation qualified majority

PURPOSE : to adapt the provisions relating to Commission committees laid down in Council instruments adopted in accordance with the consultation procedure (qualified majority). **CONTENT** : Decision 1999/468/EC repealed Decision 87/373/EEC. The provisions relating to committees which assist the Commission in the exercise of its implementing powers, provided for in the application of Decision 87/373/EEC should be adapted to bring them into line with the provisions of Decision 1999/468/EC: - the provisions of the instruments providing for recourse to the type I committee procedure established by Decision 87/373/EEC are replaced by provisions referring to the advisory procedure. With regard to this procedure, the instruments listed in the annex to this draft legislation are amended. - the provisions of the

instruments providing for recourse to type IIa and IIb committee procedures are replaced by provisions referring to the management procedure. - the provisions of the instruments providing for recourse to type IIIa and IIIb committee procedures are replaced by provisions referring to the regulatory procedure.?

CONTENT : the Council adopted two Regulations on comitology provisions laid down in Council acts which are subject to the consultation procedure and based, respectively, on unanimity or qualified majority voting within the Council.?
