Agricultural products and foodstuffs: designation of origin, geographical indication (amend. Regulation (EEC) No 2081/92)

PURPOSE: To update Community legislation on the protection of geographical indications and designations of origin for agricultural products and foodstuffs. **CONTENT:** In 1992 the European Union set up legally binding provisions for the protection of agricultural and/or foodstuffs relating to a particular region. It gives producers the opportunity to have the geographical names of products protected at Community level by means of registration. It does not cover wines and spirits which are already covered by other Community legislation. One of the fundamental purposes of this legislation is to protect producers and consumers from imitations that misuse geographical names. The WTO gives similar weight to this matter under the Trade-Related Aspects of Intellectual Property Rights (TRIPS). It is proposed that the 1992 Directive (No 2081/92/EEC) be updated in the following manner: - To include wine vinegar within the scope of the Directive's provisions. Currently, it is neither covered by Directive 2081/92 nor legislation protection for wines and spirits. - To remove mineral and spring waters from the register of geographical indications and designations of origin. - To clarify the rules on homonyms. - To extend the application of an objection procedure to nationals of WTO member countries. - Enhanced provisions in cases where a PDO or PGI holder wishes to cancel their registration. - To apply the same rules of the Regulation to agricultural products or foodstuffs originating in a third country, without prejudice to international agreements. - To introduce changes concerning the date of registration to bring the Regulation in line with the TRIPS Agreement. - To delete the simplified procedure on the grounds that it does not offer a right of objection. - To make minor changes to standard EN 45011 applying to inspection bodies. - To ensure that cancelled registrations are published as a Decision.?

The committee adopted the report by Jean-Claude FRUTEAU (PES, F) amending the proposal under the consultation procedure. It wanted a

number of new products to be added to the registers, including vinegar made from the Corinthian grape, mustard paste, berry wine, wool and osier. Moreover, it argued that the regulation should also apply to products derived from tobacco which are typical of a given area (such as Tuscan cigars). Other amendments dealt with the following points: - protection for product names from WTO countries that are not members of the EU should be conditional upon those countries guaranteeing equivalent protection for EU products; - cancelled registrations should not be reattributable during a period of five years; - where appropriate, the right holders of a registered product should also be able to decide that packaging shall take place solely in the defined geographical area, thereby making it easier for stringent checks to be carried out on the products packaged and product quality and traceability to be guaranteed; - while agreeing that natural mineral and spring waters should be removed from the scope of the regulation, the committee wanted to allow a ten-year transitional period, rather than five years as proposed by the Commission; - the Commission should set up a database on all PDOs and PGIs already registered or for which an application has been lodged. ?

The European Parliament adopted a resolution drafted by Jean-Claude FRUTEAU (PES, France) and amended the Commission's proposal. (Please refer to the document dated 5/11/02.) Parliament also made the following amendment: - if the application concerns a name that also indicates a border geographical area, or a traditional name connected with that geographical area situated in a Member State, the third country to which the application is made must consult the Member state in question. If the groups agree on an overall solution, the countries concerned may submit a joint application for registration.?

Agricultural products and foodstuffs: designation of origin, geographical indication (amend. Regulation (EEC) No 2081/92)

PURPOSE : to amend Regulation 2081/92/EEC on the protection of geographical indications and designations of origin for agricultural products and foodstuffs. COMMUNITY MEASURE : Council Regulation 692/2003/EC. CONTENT : the Council adopted this Regulation by qualified majority, the Danish delegation voting against and the United Kingdom delegation abstaining. The Regulation includes wine vinegar within the scope of its provisions. It excludes from its scope mineral and spring waters after a transitional period of ten years - instead of five years in the initial proposal - with a progressive phasing out. It includes new products such as mustard, pasta, wool, and wicker and set provisions to end the coexistence between a registered designation and an identical geographical name after a fifteen years period. Producer groups now have the ability to indicate in their product specifications that packaging shall take place solely in the defined geographical area. At the request of the Italian delegation, a statement is added regarding the risk of conflict between rules for the registration of plant varieties and those relating to geographical indications and designations of origin.
