## European Parliament: termination-of-service for officials and temporary staff in the political groups

AIM: To enable the officials and temporary staff of the political groups who are affected by the redeployment of human resources in the European Parliament to take early retirement. CONTENT: When consulted by the Council on the proposal presented by the Commission for a Regulation introducing special measures to terminate the service of officials of the Commission of the European Communities as part of the reform of the Commission (see document CNS/2001/0027), the European Parliament put forward amendments, the chief purpose of which was to extend this early-retirement scheme to the other institutions, especially the European Parliament. While declaring itself amenable to the idea of extending the early-retirement scheme to the other institutions, the Council took the view that the institutions must justify their needs and provide evidence that their planned measures would have no net impact on the Community budget and that their participation in the scheme would be covered by separate Regulations. The European Parliament estimated that the service of 100 officials and 24 temporary employees of the political groups could be terminated over a three-year period. The aim of the present proposal is therefore to authorise the release of 100 officials and 24 temporary employees of the political groups in the European Parliament between 2002 and 2004. Provided that the operation has no net budgetary impact, the savings from these staff cuts (the difference between the cost of full remuneration and that of the redundancy packages) should pay for the recruitment of some 47 new officials and 11 temporary employees. ?

The committee adopted the report by Giuseppe GARGANI (EPP-ED, I) approving the Commission's amended proposal without amendments under the consultation procedure (reconsultation of Parliament).?

#### European Parliament: termination-of-service for officials and temporary staff in the political groups

In a letter received at the Court on 11 April 2002 the Council requested the Court's opinion on this proposal. The proposal is to authorise a termination-of-service scheme, between 2002 and 2004, for 100 Parliament officials and 24 temporary staff working in the Political Groups in

order to take account of the need to renew professional skills. The Court has examined the proposal and states that the increase in future pension costs due to the appointment of the new staff seems not to have been taken into consideration. It suggests that the proposal should define which budgetary mechanism will be used to ensure that the savings will actually be safeguarded in the long term. Moreover, the Court is of the opinion that the preamble to the proposed regulation should explain the coherence of the scheme with the European employment policy objective of increasing the employment rate of older workers through flexible and gradual retirement formulas. The Court takes note that no appropriate and clear selection criteria are established. The implementation of the scheme, according to the Court, should ensure that staff who are able to update their skills are fairly treated. The preamble to the proposed regulation should explain why the scheme should apply to temporary staff whose contracts could be simply terminated. Lastly, the Court is of the opinion that an early retirement system such as the one proposed should be a one-off solution. In the future the focus should be on improvement of staff development policy.

### European Parliament: termination-of-service for officials and temporary staff in the political groups

PURPOSE: to enable the officials and temporary staff of the political groups who are affected by the redeployment of human resources in the European Parliament to take early retirement. COMMUNITY MEASURE: Council Regulation 1748/2002/EC, Euratom introducing, in the context of the modernisation of the institution, special measures to terminate the service of officials of the European Communities appointed to an established post in the European Parliament and temporary staff working in the Political Groups of the European Parliament. CONTENT: to recall, the European Parliament has been engaged in a thorough restructuring of its way of operating since 1997, when the Bureau adopted the new staff policy, based on the grounds of the new tasks conferred on the European Parliament by the Treaties. In the light of four years experience of implementing this new policy, and with a view to establishing a longer term policy for recruitment, meeting foreseeable requirements for specific required skills, the European Parliament has been studying its human resource requirements for the years to come, as part of an exercise to draw up an operational list of duties and tasks. The European Parliament is taking the necessary steps, mainly through training, to help redeployed staff to adjust in the most satisfactory and effective way possible. However, the skills of a section of officials and temporary staff working in the Political Groups, who have reached the age of 55 and who have completed at least 15 years of service, are deemed to be too far removed from the duties to be performed. The European Parliament needs new skill profiles and a rebalancing of its establishment plan, but the number of officials retiring in the normal way will not be sufficient to allow the necessary skills to be acquired through recruiting new officials and temporary staff within a satisfactory timescale. Special measures should accordingly be adopted with regard to termination of service together with internal administrative arrangements for effective monitoring of the implementation of this Regulation. These measures must be applied as far as possible with due regard for geographical balance, in compliance with the provisions of this Regulation. These measures must be budget-neutral. To this end a monitoring mechanism should be set up by the budgetary authority. This Regulation authorises the European Parliament, in the interests of the service and in order to take account of the need to renew skills arising from the process of adjusting its resources to its activities, to adopt measures up to 31 December 2004 for terminating the service of officials and temporary staff working in the Political Groups who have reached the age of 55 and have completed at least 15 years service, with the exception of those in Grades A 1 and A 2, under the conditions specified by this Regulation. The total number of officials to be covered by the measures shall be 100. The total number of temporary staff working in the Political Groups to be covered by the measures shall be 24. Respect for budgetary neutrality shall be monitored during the annual budget procedure. To this end, the Appointing Authority shall, taking into account the link between the number of officials whose service was terminated and the number ofofficials recruited, report to the budgetary authority at the appropriate time, certifying that the condition of budgetary neutrality is met. ENTRY INTO FORCE: 3 October 2002. These measures shall apply until 31 December 2004.?
