European Central Bank ECB: appointment of Lucas Papademos as Vice-President

PURPOSE : to propose the appointment of Vice-President of the European Central Bank. CONTENT : on the 15 April 2002, the Council presented a recommendation in which it proposes to appoint Mr M. Lucas D. PAPADEMOS to the office of the Vice-President of the European Central Bank for a period of 8 years with effect from 1 June 2002. The Parliament is called upon to comment on the appointment of the Mr PAPADEMOS, according to the consultation procedure.?

European Central Bank ECB: appointment of Lucas Papademos as Vice-President

This document sets out the Council's recommendations on the appointment of the Vice-President of the Executive Board of the European Central Bank. In particular, the Council recommends that Lucas D. PAPADEMOS be appointed Vice-President of the Executive Board of the European Central Bank for a term of office of eight years with effect from 1 June 2002. This recommendation shall be submitted to the Heads of State or Government of the Member States which have adopted the euro, after consulting the European Parliament and the Governing Council of the European Central Bank.?

COMMUNITY MEASURE : Decision 2002/368/EC taken by common accord of the Governments of the Member States that have adopted the euro at the level of Heads of state or Government appointing the Vice-President of the European Central Bank. CONTENT : Mr Lucas D. Papademos is appointed Vice-President of the European Central Bank for a term of office of eight years. This appointment takes effect from 01/06/02.?
