## The role of the regional and local powers in the European construction

The committee adopted the own-initiative report by its chairman, Giorgio NAPOLITANO (PES, I), on the role of regional and local authorities in European integration. The report contained general recommendations as well as proposals for amendments to certain articles of the treaties. MEPs believed that the hierarchical pyramid structure of the EU's institutional system should be abandoned and that local and regional authorities should be more involved in the European decision-making process. They called on the Commission, when drafting legislation and devising Community policies, to involve in the process, "on a full and regular basis", those who are required to implement these laws and policies, with the precise arrangements for participation by regional and local authorities being determined by national structures. The report also expressed the hope that consultation of regional or local interests would "principally take place via the Committee of the Regions or via the most representative European associations for the defence of regional, urban and local interests". It added that the right to take an issue to the Court of Justice where the subsidiarity principle is presumed to have been breached should be shared between the Committee of the Regions and regional and local authorities which have legislative powers. The committee also sought to add to the treaty an article on linguistic diversity, saying that the Community should, within its spheres of competence, respect and promote linguistic diversity in Europe "including regional or minority languages as an expression of that diversity". MEPs also believed it was important to foster transfrontier cooperation at all levels as this was "a European task and a political objective of the EU". Lastly, the European Convention was asked to examine the role of regional and local authorities in European integration.?

## The role of the regional and local powers in the European construction

The European Parliament adopted a resolution based on the own-initiative report drafted by Giorgio NAPOLITANO (PES, Italy) on the role of regional and local authorities in building Europe. It called for the relevant provisions of the European Constitution to recognise the role of the regions, provinces, communes and any regional or local organisation which forms part of the Member States in the pursuit of the objectives of the European Union. The European Constitution should define precisely the exercise, application and monitoring of the subsidiarity principle. Where the transposition of directives into national law falls within the competence of the regions, the latter should enjoy the same flexibility as regards the choice of methods as the national authorities when they are competent. The Member States must strengthen the internal mechanisms which provide for participation by the regions and territorial authorities, in particular those endowed with legislative powers, in all aspects of the process of policy formation that are of specific interest to them. Parliament supported the concept set out in the Commission White Paper on European governance which sees the regions and municipalities acting as intermediaries between the individual and the European institutions. It hoped that alongside the direct consultation of regional and local interests, consultation would principally take place via the Commission should, therefore, act on the appropriate proposals of principle set out in the White Paper on European governance. Parliament went on to state that the Convention must ensure that regions and other territorial entities may defend their rights before the Court of Justice under the authority of the Member State concerned, according to its constitutional or national legislation. Finally, Parliament proposed several amendments to the Treaties with respect to the rights, powers and autonomy of regional and local authorities.?
