## Europol: Staff regulations, Director and Deputy Directors. Initiative Belgium, Netherlands and Luxembourg

PURPOSE: to amend the Staff Regulations for Europol employees. CONTENT: These amendments to the Europol Staff Regulations deal in particular with the procedures for the nomination of the director and Deputy Directors, and for the application of other powers in their respect. Appendix 8 of the Regulations is replaced with new provisions that cover: -selection procedures; -termination of service, with reference to resignation; compulsory resignation; retirement in the interests of the service; dismissal, and retirement. -disciplinary proceedings, including disciplinary measures and special provisions for the case provided for in Article 29(6) of the Europol Convention; -appeals; -special provisions concerning the Director.?

# Europol: Staff regulations, Director and Deputy Directors. Initiative Belgium, Netherlands and Luxembourg

The committee adopted the report by Gérard DEPREZ (EPP-ED, B) recommending that Parliament reject the initiative under the consultation procedure. While it agreed with the substance of the initiative, which it felt to be both timely and appropriate, the committee felt that Parliament should make a political point of rejecting it as the initiative, like many others, had been forwarded to Parliament simply for form's sake without being accompanied by an explanatory memorandum justifying and explaining it and such consultation was therefore merely a bogus exercise. Moreover, no action had been taken by Council on the recommendation recently adopted by Parliament, by a very large majority, calling for the Europol Convention to be replaced by a Council decision, which would ensure that Europol was incorporated into the EU institutional system and subject to democratic oversight.?

The European Parliament adopted a resolution drafted by Gerard M. J. DEPREZ (EPP-ED, B) and rejected the initiative of Belgium, Holland and Luxembourg. (Please refer to the document dated 08/10/02.) The Commission and/or the Presidency were asked to submit a fresh initiative which is in keeping with the enacting terms proposed by the recommendation to the Council adopted by Parliament on 30 May 2002 on the automatic incorporation into the EU's institutional system.?
