## Amending and supplementary budget 4/2002

PURPOSE : to present the preliminary draft supplementary and amending budget No 4 to the budget for 2002. CONTENT : this Preliminary Draft Supplementary and Amending Budget (PDSAB) No 4/2002 contains the following elements in section III - Commission: - the mobilisation of the remaining margin under the ceiling of the financial perspective heading 4, in favour of the aid to Afghanistan; - the modification of the remarks of a budget line dedicated to the internal market, in order to fund actions in the field of customs. Following the events of September 11 th, and the subsequent developments, the European Union has committed itself to actively participate to the financial efforts in favour of Afghanistan and the neighbouring region. It has played a major role, hosting the Bonn Conference, which provided the blue print for Afghanistan's future, and has declared its clear support for the long term reconstruction effort. The Budgetary Authority already decided during

the conciliation meeting at the Budget Council of 21 November 2002 to "leave a margin of EUR 70 million in Heading 4 to cover further needs in this area in 2002 (and) await more accurate estimates of these needs from the Commission". The Budgetary Authority has conditioned the use of this margin to the fulfilment of specific requirements, whose respect must be confirmed by the Commission. In particular, the Commission should demonstrate that appropriations already entered under the budget lines for Asia and for humanitarian aid are spent properly, whilst evaluating support given by other donors with respect to their commitments made in Tokyo (January 2002). Moreover, the Commission should ensure that the new appropriations could be spent in an efficient way to help the Afghan people. The Commission considers that the conditions stated above are met, and therefore presents this Preliminary Draft Supplementary and Amending budget. All the elements and justifications are included in the present proposal. Preparation on a number of foreseen components is already under way and it is expected that, out of the total EUR 70M contracts worth EUR 50M will be concluded before the end of 2002. The indicative breakdown proposed for the EUR 70M shall reinforce line B7-300, Financial and technical cooperation with Asian developing countries. An indicative breakdown proposed for the EUR 70 million accompanies the PDSAB: - human and Social Capital (the health sector and social protection) (EUR 19 million); - good Governance and Institutional Reform (support to public administration and public administrative reform) (EUR 37 million); - physical Reconstruction (support to economic infrastructure - electricity and water in Kabul and other urban infrastructures) (EUR 11 million); - pilot initiatives and studies (EUR 3 million). The budget authority approved the request on 22 July for an amount of EUR 25M. This brings the total EC funding for 2002 (including this PDSAB) up to EUR 250 million.?

## Amending and supplementary budget 4/2002

PURPOSE : to present the letter of amendment No 1 to preliminary draft supplementary and amending budget No 4/2002 (Section III-Commission). CONTENT : in the wake of the disastrous floods which struck a number of countries this August, the Commission proposed on 11 September 2002 establishing, by interinstitutional agreement, a new flexibility instrument to endow the EU Solidarity Fund which will provide relief in the event of natural, technological and environmental disasters. This fund may operate in the EU Member States and in countries negotiating for accession. It will operate in accordance with the arrangements laid down in the Council regulation on the Solidarity Fund, proposed by the Commission on 18 September 2002, which will constitute the legal basis for the expenditure (please refer to procedure reference CNS/2002/0228). In accordance with these proposals, this letter of amendment will insert two budget lines: - under heading 3, internal policies : B2-4 (new title): European Union Solidarity Fund - Member States, - under heading 7, pre-accession strategy : B7-09 (new chapter): European Union Solidarity Fund - countries negotiating for accession. These lines will be able to accommodate the fund's operations from 2002. The lines would carry token entries and would be endowed after the fund had been mobilised. ?

## Amending and supplementary budget 4/2002

PURPOSE : to present draft supplementary and amending budget No 4/2002 (Section III-Commission). CONTENT : on 20 September 2002, the Council adopted the preliminary draft supplementary and amending budget 4/2002. In view of the discussions within COREPER, a large majority of delegations believe that the Fund itself should focus on natural disasters, thereby excluding technological and environmental disasters as suggested by the Commission. This draft incorporates the Commission's proposals, except for the deletion at the end of the first sentence of the comment relating to the new budget lines B2-400 and B7-090 "...in case of natural, technological and environmental disasters", so as to not prejudge the decision on the legal basis. Following this supplementary and amending budget 4/2002 for the financial year 2002, the total commitment appropriations rise to EUR 98.706.358.738 and the payment appropriations remain unchanged. ?

## Amending and supplementary budget 4/2002

By adopting the report by Mr Guido PODEST? (EPP-ED, I) on a Supplementary and Amending Budget 4/2002, Parliament gave its support to the budgetary structure for a European Union Solidarity Fund which aims to give relief to the victims of natural disasters in the Member States and in candidate countries. Two budget lines for the Solidarity Fund will need to be created. Parliament states that the necessary credit payments will be taken from existing non-used credits from other budget lines. In order to make the fund operational, two conditions still need to be fulfilled at this stage: a new inter-institutional agreement needs to be signed and the legal base established. It is only with a fifth Supplementary and Amending Budget that the final definitive figure will be determined for the fund. It is foreseen that the total amount will be 1 billion for this year. The fifth Supplementary and Amending Budget should be adopted by Parliament during its Strasbourg plenary session in October 2002. Parliament calls on the Commission to submit Preliminary Draft Supplementary and Amending Budget No 5/2002 as soon as possible. The House also approved an increase of 70 million to support reconstruction measures in Afghanistan. Lastly, the Parliament approved unamended the Draft Supplementary and Amending Budget No 4/2002 drawn up by the Council on 20 September 2002 (please refer to summary dated 20/09/02).?

## Amending and supplementary budget 4/2002

OBJECTIVE: final adoption of SAB No 4/2002. COMMUNITY MEASURE: 2002/846/EC, Euratom. CONTENT: the European Parliament finally adopted the European Union's Supplementary and Amending Budget No 4/2002 in accordance with its resolution of 26 September 2002 (see summary of the resolution). ?
