## EC/Senegal fisheries agreement: protocol for the period from 1st July 2002 to 30 June 2006

PURPOSE : on the conclusion of the Protocol setting out the fishing opportunities and the financial contribution provided for by the Agreement between the EC and the Government of the Republic of Senegal on fishing off the coast of Senegal for the period from 1 July 2002 to 30 June 2006. CONTENT : the latest protocol annexed to the fisheries agreement between the EC and Senegal expired on 31.12.2001. The latest round of negotiations to renew the protocol, which took place in Dakar on 24 to 25 June 2002, resulted in the initialling of a new protocol. The new protocol, which covers the period from 1 July 2002 to 30 June 2006, will be the 17th since the entry into force of this fisheries agreement. It grants fishing opportunities for 78 tuna vessels and 8000 GRT for trawlers and longliners. Compared to the previous Protocol there has been a considerable reduction of the fishing possibilities on the socially, politically and economically sensitive segments: the coastal demersal segment has been reduced by 30% and the pelagic segment has been excluded from the new Protocol. The overall financial contribution to be paid to Senegal has been increased from EUR 12 million per year to EUR 16 million per year. Out of this amount, the Protocol foresees EUR 3 million/year for the development of a partnership aiming at, inter alia, stock evaluations, control and the surveillance of the fishing activities, the improvement of the safety of the small-scale fishing vessels and institutional support for the introduction of sustainable and responsible fishing. This partnership constitutes an innovative element which did not exist in the previous protocol and which shows the desire of the two parties to contribute to the development of sustainable and responsible fisheries. Moreover, this partnership envisages a programming and follow-up mechanism, which is in line with the other fishing agreements concluded by the Community with third countries. In this respect, it should also be stressed that, within the framework of the partners

application of the protocol, an evaluation and an audit of all the partnership actions. The protocol includes several more positive elements, for example: - for the first time, the new protocol EC/Senegal envisages a continuous monitoring of the development of the state of stocks. To this end, Article 3 of the protocol foresees an annual scientific meeting. On the basis of the conclusions of the scientific meeting, the Joint Committee can adopt appropriate measures of the durable management of resources, including -if necessary -a reduction in the fishing opportunities. - the new way of calculating the fishing possibilities for trawlers and longliners ("per month, averaged over the year") will show the actual fishing effort deployed and will involve a larger flexibility for the EC fishery. It will also most likely bring about a larger rate of utilisation of the fishing possibilities (cost/benefit). - the advances paid by ship-owners have been increased. - the technical conditions have been strengthened (introduction of yearly obligatory biological resting periods, reduced fishing zones, reduced allowed by-catches, larger mesh sizes and increased obligatory landings). - the number of Senegalese observers and seamen on board Community vessels has been increased. In view of the above, the new Protocol is considered to be good value for money and will encourage the responsible and sustainable exploitation of the resources to the mutual benefit of the Community and Senegal. As regards the licence applications, the proposal states that if licence applications from the following Member States (Greece, Spain, Italy, Portugal and France) do not cover all the fishing opportunities fixed by the Protocol, the Commission may take into consideration licence applications from any other Member State. The committee adopted the report by Manuel PEREZ ALVAREZ (EPP-ED, E) broadly approving the proposal subject to a few amendments (under the consultation procedure). The committee was concerned that Parliament should be provided with better information to enable it to carry out its duties under the consultation procedure and therefore stipulated that, before any agreement on renewal of the protocol, the Commission should submit to Parliament and Council a general assessment report on the implementation of the Agreement, as well as a copy of the report on the targeted measures which the authorities of Senegal were required to provide under the protocol. Lastly, the report called for the Protocol to incorporate the social clause adopted by the sea fishing industry Social Dialogue Committee in December 2001 guaranteeing equal treatment for both EU and non-EU seamen sailing on EU vessels in such matters as freedom of association, collective bargaining and living and working conditions. ?

COMMUNITY MEASURE : Council Decision 2002/999/EC on the conclusion of the Agreement in the form of an Exchange of Letters concerning the provisional application of the Protocol setting out the fishing opportunities and the financial contribution provided for by the Agreement between the European Economic Community and the Government of the Republic of Senegal on fishing off the coast of Senegal for the period from 1 July 2002 to 30 June 2006. CONTENT : this Decision aims to provisionally apply the protocol setting out the fishing opportunities and the financial contribution between European Economic Community (EEC) and Senegal on fishing off the coast of Senegal between 1 July 2002 and 30 June 2006 (for more information on the Protocol please refer to the summary dated 16 December 2002). To this effect, both parties therefore initialled an Agreement in the form of an Exchange of Letters, temporarily applying the Protocol from 1 July 2002.

## EC/Senegal fisheries agreement: protocol for the period from 1st July 2002 to 30 June 2006

PURPOSE : to conclude the Protocol on fishing between the EEC and Senegal. COMMUNITY MEASURE : Council Regulation 2323/2002/EC on the conclusion of the Protocol setting out the fishing opportunities and the financial contribution provided for by the Agreement between the European Economic Community and the Government of the Republic of Senegal on fishing off the coast of Senegal for the period from 1 July 2002 to 30 June 2006. CONTENT : The above-mentioned Protocol is approved and attached to this Regulation. It sets out the fishing opportunities allocated among the Member States as follows: Category 1 : - 233 gross registered tonnes (GRT) per quarter - Greece - 704 GRT per quarter - Spain; - 563 GRT per quarter - Italy; Category 2 : - 3 000 GRT per month averaged over the year - Spain; Category 3 : - 3 186 GRT per month averaged over the year - Spain; - 314 GRT per month, averaged over the year - Portugal; Category 4 : - 10 vessels - Spain; - 6 vessels - France; Category 5 : - 21 vessels - Spain; - 18 vessels - France; Category 6 : - 20 vessels - Spain; - 3 vessels - Portugal If licence applications from these Member States do not cover all the fishing opportunities fixed by the Protocol, the Commission may take into consideration licence applications from any other Member State. The obligation of direct landing by freezer tuna seiners will be met by Community shipowners on the basis of the following breakdown: -vessels flying the French flag: 44 % -vessels flying the Spanish flag: 56 %. The Member States must notify the Commission of the quantities of each stock caught in the Senegalese fishing zone. ENTRY INTO FORCE : 31.12.2002.?
