Convention on the future of the European Convention: financing, extension Interinstitutional Agreement of 28/02/2002

PURPOSE: to present an Interinstitutional Agreement extending the Interinstitutional Agreement of 28 February 2002 on the financing of the Convention on the future of the European Union. CONTENT: on 28 February 2002 the European Parliament, the Council and the Commission signed an Interinstitutional Agreement (ACI/2002/2047) on the financing of the Convention on the future of the European Union, to apply until 31 December 2002. That Agreement needs to be extended until the end of the Convention proceedings or until the end of the 2003 budgetary year, whichever is the earlier. The contribution of the European Parliament, the Council and the Commission to the financing of the Convention should furthermore be fixed for that period according to a new allocation as follows: - European Parliament: (p.m.); - Council: EUR 200 000; - Commission: EUR 750 000. Therefore, the draft Budget for 2003 totals EUR 950 000. The Agreement shall enter into force on 1 January 2003?

Convention on the future of the European Convention: financing, extension Interinstitutional Agreement of 28/02/2002

On 8 November 2002, the Representatives of the Governments of the Member States (COREPER), meeting within the Council, approved a draft decision of 21 February 2002 setting up a Fund for the financing of the Convention on the future of the European Union and laying down the financial rules for its management (refer to procedure reference ACI/2002/2047). The Representatives of the Governments of the Member States have decided that this decision, of 21 February 2002, shall be extended from 1 January 2003 until the end of the Convention's proceedings or until December 2003, whichever is the earlier.?

PURPOSE: to conclude an Interinstitutional Agreement extending the Interinstitutional Agreement on the financing of the Convention on the future of the European Union. COMMUNITY MEASURE: Interinstitutional Agreement extending the Interinstitutional Agreement on the financing of the Convention on the future of the European Union. CONTENT: this Agreement is to be extended until the end of the Convention's proceedings or until the end of the 2003 budgetary year at the latest. The contribution of the European Parliament, the Council and the Commission to the financing of the Convention is thus fixed for that period: - European Parliament: p.m. - Council: EUR 200 000, - Commission: EUR 750000. ENTRY INTO FORCE: This Agreement shall enter into force on 1 January 2003.?

Convention on the future of the European Convention: financing, extension Interinstitutional Agreement of 28/02/2002

This document comprises of a Commission Decision on the draft agreement of the 2003 budget of the Convention on the Future of Europe and on the extension of the relevant interinstitutional agreement. The Decision stipulates that the Commission accepts to contribute EUR 750 000 to the financing of the Convention in 2003 and approved the interinstitutional agreement between the European Parliament, the Council and the Commission to extend the IIA of 28 February 2002 on the financing of the Convention on the Future of the European Union.?
