Cereals: calculation of import duties (amend. Regulation (EEC) No 1766/92)

PURPOSE: to amend Regulation 1766/92/EC with regard to the calculation of import duties on certain cereals. CONTENT: on 26 July 2002, the Council authorised the Commission to notify the WTO that the European Community intended to amend the concessions for cereals falling within CN codes 1001 10 50 (durum wheat), 1001 90 95 (common wheat, other than spelt for sowing and durum wheat), 1002 00 00 (rye), 1003 00 50 (barley), 1005 (maize, other than maize from hybrid seed) and 1007 00 90 (sorghum, other than hybrid sorghum for sowing) set out in Schedule CXL annexed to the GATT and that it was willing to enter into negotiations and consultations with WTO members under Article XXVIII of the 1994 GATT agreement. The Commission has conducted negotiations in consultation with the 133 Committee in accordance with the negotiating directives laid down by the Council. Negotiations with the authorities of the United States and Canada, who have negotiating rights for products falling within CN codes 1001 90 95 (common wheat, other than spelt for sowing and durum wheat) and 1003 00 50 (barley), have been concluded in the form of an exchange of letters. The application of these agreements makes it necessary to amend certain provisions of Regulation 1766/92/EEC.?

The committee adopted the report by Dominique SOUCHET (Ind, F) tabling one amendment to the proposal under the consultation procedure. It sought to ensure that cereals covered by CN code 1001 1000 (durum wheat) would also be included among the products subject to a higher rate of import duty as provided for in the regulation.?

PURPOSE: to amend the calculation of import duties on certain cereals. COMMUNITY MEASURE: Council Regulation 1104/2003/EC amending Regulation 1766/92/EC with regard to the calculation of import duties on certain cereals. CONTENT: the Council adopted a

Regulation amending Regulation 1766/92/EEC with regard to the calculation of import duties on certain cereals. The Swedish delegation abstained and the Danish delegation voted against. The Regulation amends notably Article 10(2) of Regulation 1766/92/EEC by excluding some products from the calculation of the import duty equals to 155% of the intervention price minus the cif import price. It should be noted that on 26 July 2002, the Council authorised the Commission to notify the WTO that the European Community intended to amend the concessions for certain cereals in the European Community Schedule CXL annexed to the GATT and that it was willing to enter into negotiations and consultations with WTO members under Article XXVIII of the 1994 GATT agreement. The negotiations between the Commission and the United States and Canada in the WTO framework led to the conclusion of agreements in the form of exchanges of letters, signed respectively on 27 December 2002 (with the United States) and 31 March 2003 (with Canada). The Commission then proposed the adoption of the corresponding amendments to the basic "cereals" Regulation 1766/92/EEC. ENTRY INTO FORCE: 30 June 2003. It shall apply from 1 January 2003.?
