Republic of Cyprus: application for accession to the European Union

The European Parliament adopted the resolution, by 507 votes for, 29 against and 26 abstentions, drafted by Jacques POOS (PES, Luxembourg) and gave its assent to the application by the Republic of Cyprus to become a member of the EU. Parliament stated that this assent would not determine its position on the adjustment of the financial perspectives to cater for enlargement according to point 25 of the Interinstitutional Agreement of 6 May 1999.?
