The European Parliament adopted the resolution drafted by Elisabeth SCHROEDTER (Greens/EFA, Germany) by 522 votes for, 22 against and 24 abstentions and gave its assent to the application by the Republic of Latvia to become a member of the EU. Parliament stated that this assent would not determine its position on the adjustment of the financial perspectives to cater for enlargement according to point 25 of the Interinstitutional Agreement of 6 May 1999.?
