## EC/Guinea fisheries agreement: protocol for the period from 1st January 2003 to 31st December 2003

**PURPOSE:** to extend the fishing protocol between the European Community and the Revolutionary People's Republic of Guinea by one year.  
**CONTENT:** in 2002 a scientific survey was commissioned which sought to establish the state of fishing resources off the coast of Guinea. Due to technical difficulties this had to be postponed from June 2002 to October 2002. As a result of this delay critical data relating to fishing resources was only made available at the beginning of 2003. In the absence of further scientific and technical data the two parties concluded that a fishing Protocol establishing longer term goals will be difficult to define. Thus, the EU and Guinea are now seeking a second one-year extension of the existing Protocol. This extension, in the form of an Exchange of Letters, sets out the technical and financial conditions governing the fishing activities of Community vessels off the Guinean coast from 1 January 2003 to 31 December 2003. The Commission therefore, proposes an adoption of the Agreement in the form of an Exchange of Letters on the extension of the Protocol.?

## EC/Guinea fisheries agreement: protocol for the period from 1st January 2003 to 31st December 2003

The committee adopted the report by Juan OJEDA SANZ (EPP-ED, E) approving the conclusion of the agreement under the consultation procedure, subject to just two amendments reflecting the position that Parliament has consistently adopted with regard to the renewal of various fishing agreements. Believing that Parliament should be provided with better information to enable it to carry out its duties under the consultation procedure, the committee stipulated that, before undertaking any negotiations on renewal of the Protocol, the Commission should submit to Parliament and Council a general assessment report on the implementation of the Agreement. The report should include a cost benefit analysis which should in turn ensure that the financial compensation for special measures for sustainable development contributes to improving the living conditions of the people of the country concerned. Only after this report has been received and Parliament consulted should the Council authorise the Commission to enter into negotiations for adopting a new Protocol.?

**PURPOSE** : to conclude a agreement under the form of an exchange of letters to extend the 2000-2001 fishing protocol with Guinea  
**LEGISLATIVE ACT** : Council Regulation 1765/2003/EC on the conclusion of the Agreement in the form of an Exchange of Letters concerning the extension of the Protocol setting out the fishing opportunities and financial contribution provided for in the Agreement between the European Economic Community and the Government of the Republic of Guinea on fishing off the Guinean coast for the period 1 January 2003 to 31 December 2003. **CONTENT** : the Council unanimously adopted the Regulation on the conclusion of the Agreement setting out the fishing opportunities and the financial contribution provided for between the European Economic Community and the Government of the Republic of Guinea on fishing off the Guinean coast for the period 1 January 2003 to 31 December 2003. This agreement, which is based on Article 300 of the Treaty, provides for fishing opportunities for trawlers and tuna boats allocated between Spain, Italy, Greece, Portugal and France. The fishing opportunities for trawlers and tuna boats fixed in the Protocol shall be allocated pro rata temporis among the Member States as follows: a) fin-fish/cephalopods: 844 GRT for the Spanish vessels; 750 GRT for the Italian vessels and 906 GRT for the Greek vessels; b) shrimps: 1 050 GRT for the Spanish vessels; 300 GRT for the Portuguese vessels; 150 GRT for the Greek vessels; c) tuna seiners: 19 French vessels and 19 Spanish vessels; d) pole-and-line tuna vessels: 7 French vessels and 7 Spanis vessels; e) surface longliners: 14 Spanish vessels and 2 Portuguese vessels. If licence applications from these Member States do not cover all the fishing opportunities fixed by the Protocol, the Commission may take into consideration licence applications from any other Member State. **ENTRY INTO FORCE** : the Regulation shall enter into force 12/10/2003.?
