Active European citizenship: grants to civic participation actions, 2004-2008 action programme

This document consists of proposal for basic acts for grants currently covered by the Commission administrative autonomy (Part A of the budget) i.e. CNS/2003/0110 et 116 and COD/2003/0109, 0113, 0114 and 0115. The report highlights that a number of grants have for many years been financed on the basis of appropriations entered in part A (administrative appropriations) of the Commission section of the budget (section III). The main reason why they were located in that section was that there were no basic acts allowing them to be classified as operational appropriations. Their inclusion in part A means that they may be regarded as Commission administrative expenditure, which does not require basic acts for its implementation. Similarly, a number of grants are financed from Part B of the budget (operational appropriations) without being covered by a specific basic act. These grants are generally entered in Chapter B3-30 and thus do not require a basic act

because of institutional prerogatives in the field of information. Lastly, there are a number of grants that were temporarily attached to existing basic acts, i.e. the grants relating to the Platform of European Social NGOs. Most of these grants have a common aim, namely to strengthen organisations or promote action that reinforces the European message. They are, however, applied in very different areas of activity governed by different Treaty provisions. Once it was decided to base the construction of the Commission budget on Activity-based Budgeting (ABB), which is now enshrined in Article 41 of the Financial Regulation, it became clear that there was a need to adopt proposals for basic instruments for part A grants that had none. The Commission accordingly undertook a review of the budget appropriations that should be regarded as administrative and those that were operational. Some expenditure currently classified as operational appropriations, such as the BA lines or the administrative part of the research appropriations (B6), has been placed in the administrative part of the budget (Chapter 01). Conversely, some expenditure, such as the Part A grants, which had been regarded as "administrative", has been reclassified as operational appropriations. However, Article 49(2) of the new Financial Regulation provides that, with the exception of institutional prerogatives, pilot projects, preparatory measures and the administrative appropriations for each institution, all operational expenditure requires a basic act in order to be implemented. Therefore, it was accordingly necessary to propose establishing basic acts for the grants currently in Part A. Each basic act, whether providing for operating grants or grants for actions, takes the form of funding for a programme covering a period of 2 to 6 years. Where an act is related to a Treaty article involving codecision, the Commission proposes that the Council and Parliament adopt the total funding required for the programme throughout its life, in accordance with the rules in Article 33 of the Interinstitutional Agreement of 6 May 1999 on improving the budgetary procedure. The adoption of basic acts will not alter the headings of the financial perspective to which the funding of the grants is attached, at least until expiry of the current financial perspective in 2006. In principle, the basic acts should therefore be adopted by the legislature in order to be applicable by 2004. In the event of failure to achieve that objective, the Commission will propose transitional derogations enabling grants to be awarded in 2004, pending adoption of the basic acts.?

Active European citizenship: grants to civic participation actions, 2004-2008 action programme

PURPOSE : to provide a basic act for the funding of programmes actively promoting European citizenship. **CONTENT** : the European Union is committed to promoting active European Citizenship. For several years support has been provided for this commitment under headings in Part A and B of the EU's budget. They include co-financing for the operating costs of: - the Association of the Councils of State and Supreme Administrative Jurisdictions of the European Union; - the "Our Europe" Association; - European think-tanks and organisations advancing the idea of Europe; - the activities of associations and federations of European interest; - the European Council on Refugees and Exiles; - the Jean Monnet House and the Robert Schuman House; - town twinning schemes in the EU; - the promotion of European citizenship ; - measures for civil society by means of grants to non-governmental organisation and trade union organisations; and - the operating costs of the Platform of European Social NGO's. The adoption of an EU Council Regulation on the financial regulation applicable to the general budget of the European Communities and the decision to base the structure of the Commission budget on an Activity Based Budgeting (ABB) approach require basic acts to be adopted for a number of grants hitherto financed under appropriations entered in administrative appropriations of the Commission section of the budget. The purpose of this Decision is to adopt an act providing a basis for grants towards the promotion of active European citizenship and is to last for a period of five years (2004-2008). The amounts provided for are largely based on those allocated in the budget of the European Union for the 2003 financial year. The total amount proposed is EUR 113.092 million.?

Active European citizenship: grants to civic participation actions, 2004-2008 action programme

The European Parliament adopted a resolution drafted by Heide RÜHLE (Greens/EFA, D) and amended the proposal. The resolution was voted by 371 votes in favour, 62 against and 10 abstentions. The main amendments were as follows: - the general objective of the programme is to reduce the democratic deficit of the EU while increasing transparency; - the budget for the programme was increased to EUR 149.192.300 million; - the programme should be extended so as to provide a legal basis for Info Points, which recently had its grant cancelled. Commissioner Neil KINNOCK stated at the Plenary that the Commission does not approve amendments seeking to widen the scope of the programme. The Commission also rejects the amendment on Info Points.?

Active European citizenship: grants to civic participation actions, 2004-2008 action programme

PURPOSE : to provide a basic act for the funding of programmes actively promoting European citizenship. **LEGISLATIVE ACT** : Council Decision 2004/100/EC establishing a Community action programme to promote active European citizenship (civic participation). **CONTENT** : This Decision establishes a Community action programme to support bodies working in the field of active European citizenship and to promote actions in this field. The programme has the following objectives: - to promote and disseminate the values and objectives of the EU; - to bring citizens closer to the EU and its institutions and to encourage them to engage more frequently with its institutions; - to involve citizens closely in reflection and discussion on the construction of the EU; - to intensify links and exchanges between citizens from the countries participating in the programme, notably by way of town-twinning arrangements; - to stimulate initiatives by the bodies engaged in the promotion of active and participatory citizenship. The activities supported by the programme seek to support the operation and to promote the actions of the bodies pursuing the programme's objectives in accordance with the criteria set out in the Annex. This support takes the form of one of two types of grant: - either an operating grant to co-finance expenditure associated with the permanent work programme of a body which pursues an aim of general European interest in the field of active European citizenship or an objective forming part of the European Union's activities in this area; - or a grant to co-finance a specific action in this area. Support includes co-financing for the operating costs of: - the Association of the Councils of State and Supreme Administrative Jurisdictions of the European Union; - the "Our Europe" Association; - European think-tanks and organisations advancing the idea of Europe; - the activities of associations and federations of European interest; - the European Council on Refugees and Exiles; - the Jean Monnet House and the Robert Schuman House; - town twinning schemes in the EU; - the promotion of European citizenship ; - measures for civil society by means of grants to non-governmental organisation and trade union organisations; - the Platform of European Social NGO's. The programme starts on 1 January 2004 and ends on 31 December 2006. The financial reference amount for the implementation of this programme for the period 2004 to 2006 is EUR 72 million. The annual appropriations will be authorised by the budgetary authority within the limits of the financial perspective. No later than 31 December 2007, the Commission must present to the European Parliament and the Council a report on the achievement of the programme's objectives. This report must be based, inter alia, on an external evaluation report which must be available no later than the end of 2006. **DATE OF APPLICATION** : 1/01/04. **DATE OF EFFECT** : 05/02/04.?

Active European citizenship: grants to civic participation actions, 2004-2008 action programme

PURPOSE: to report on the 'Active European Citizenship' programme, 2004-2006.

CONTENT: an evaluation of the 'Active European Citizenship' programme, which covered the period 2004-2006, found that there is a need for Community action in the field of promoting European citizenship and that the 2004-2006 programme was able to respond positively to this need. Bringing all actions together under one programme has also proved to be efficient and effective. Overall, the stated objectives of the programme have been consistently implemented through the various actions and the programme had been successful at targeting clearly defined groups. At the same time, however, the evaluation finds that the budget is not large enough to meet the programmes stated objectives. Thus, whilst the programme's remit was broad its resources, by comparison, were not. This could risk a gap emerging between the programmes stated objectives and its capacity to deliver.

Overall findings: Generally speaking, the report's findings indicate that the programme was stronger on horizontal actions 'those seeking to strengthen links between EU citizens, civil society organisations and municipalities than the more 'vertical' actions 'i.e. those bringing citizens closer to the EU. The latter, therefore, remains an important challenge for the new 'Europe for Citizens' programme. (See [COD/2005/0041](#)).

According to the evaluation report, the programme's activities have resulted in tangible results (such as publications), methodological learning, experiences and knowledge, policy lessons and greater European cooperation and awareness-raising about citizenship issues and other cultures. The programme has also succeeded in terms of capacity building.

Europe for citizens: In future, and within the context of the new Europe for Citizens programme, the Commission intends to implement four major thematic actions, namely:

1. Strengthening citizens' involvement: the evaluation found that it was important to involve citizens more directly when preparing the aims, objectives and actions of the new programme. As such, the direct involvement of citizens in implementing the actions is a key feature of 'Action 1' in the new programme. New types of activities, such as citizens' panels have been adopted. Based on the result of the pilot projects, the new measures should be mainstreamed into the new programme as of 2008. In addition, the new programme includes high-visibility events to which local authorities, civil society and European citizens will be invited, where they can voice their views and opinions.
2. Strengthening coherence and encouraging partnership: the challenge of strengthening the internal coherence of the programme was recognised by the European Commission. The new programme reflects this challenge and as a result, the new programme seeks to offer greater coherence between the various actions.
3. Improving national links: it is important to promote and encourage links with national programmes, particularly in the field of active citizenship. This could be achieved through improving contacts with the national authorities who are responsible for civic participation. Such linking, the Commission notes, will have a positive impact on the sense of national ownership in the field of European citizenship. The 'Programme Committee', established under the new citizenship programme, offers the Commission a good opportunity to develop a dialogue with the Member States. Many Member States are in the process of establishing coordination and support structures for the 'Europe of Citizens' programme.
4. Enhancing programme management: the report identifies three areas where the programme's management could be improved: i) finance and administration; ii) monitoring and evaluation; and iii) added value, dissemination and partner search. The Commission finds these recommendations useful and, as such, has already made a number of arrangements to improve the programme's overall management.

Conclusions: to conclude, the report confirms the important role that the 'Active European Citizenship' programme has played in promoting civic partnership and shared values. The programme has offered Europeans the chance to participate in the debate, to express their opinions and to feed into the European political process. It has connected people and local communities in different countries. As a result of this analysis, the Community will continue to support and promote active European citizenship by setting aside the necessary resources to achieve these objectives.

The evaluation identified certain weaknesses in the programme and highlighted areas in need of further development. On a final point, the Commission will continue to develop and strengthen dialogue between the EU institutions and all those interested in promoting EU citizenships.
