Culture: grants to bodies active at European level, 2004-2006 action programme

This document consists of proposal for basic acts for grants currently covered by the Commission administrative autonomy (Part A of the budget) i.e. CNS/2003/0110 et 116 and COD/2003/0109, 0113, 0114 and 0115. The report highlights that a number of grants have for many years been financed on the basis of appropriations entered in part A (administrative appropriations) of the Commission section of the budget (section III). The main reason why they were located in that section was that there were no basic acts allowing them to be classified as operational appropriations. Their inclusion in part A means that they may be regarded as Commission administrative expenditure, which does not require basic acts for its implementation. Similarly, a number of grants are financed from Part B of the budget (operational appropriations) without being covered by a specific basic act. These grants are generally entered in Chapter B3-30 and thus do not require a basic act because of institutional prerogatives in the field of information. Lastly, there are a number of grants that were temporarily attached to existing basic acts, i.e. the grants relating to the Platform of European Social NGOs. Most of these grants have a common aim, namely to strengthen organisations or promote action that reinforces the European message. They are, however, applied in very different areas of activity governed by different Treaty provisions. Once it was decided to base the construction of the Commission budget on Activity-based Budgeting (ABB), which is now enshrined in Article 41 of the Financial Regulation, it became clear that there was a need to adopt proposals for basic instruments for part A grants that had none. The Commission accordingly undertook a review of the budget appropriations that should be regarded as administrative and those that were operational. Some expenditure currently classified as operational appropriations, such as the BA lines or the administrative part of the research appropriations (B6), has been placed in the administrative part of the budget (Chapter 01). Conversely, some expenditure, such as the Part A grants, which had been regarded as "administrative", has been reclassified as operational appropriations. However, Article 49(2) of the new Financial Regulation provides that, with the exception of institutional prerogatives, pilot projects, preparatory measures and the administrative appropriations for each institution, all operational expenditure requires a basic act in order to be implemented. Therefore, it was accordingly necessary to propose establishing basic acts for the grants currently in Part A. Each basic act, whether providing for operating grants or grants for actions, takes the form of funding for a programme covering a period of 2 to 6 years. Where an act is related to a Treaty article involving codecision, the Commission proposes that the Council and Parliament adopt the total funding required for the programme throughout its life, in accordance with the rules in Article 33 of the Interinstitutional Agreement of 6 May 1999 on improving the budgetary procedure. The adoption of basic acts will not alter the headings of the financial perspective to which the funding of the grants is attached, at least until expiry of the current financial perspective in 2006. In principle, the basic acts should therefore be adopted by the legislature in order to be applicable by 2004. In the event of failure to achieve that objective, the Commission will propose transitional derogations enabling grants to be awarded in 2004, pending adoption of the basic acts.?

Culture: grants to bodies active at European level, 2004-2006 action programme

PURPOSE : to provide a basic act for the funding of bodies active at European level in the field of culture. CONTENT : the European Union is committed to promoting European cultural networks. For several years support has been provided for this commitment under headings in Part A of the EU's budget. They include co-financing for the operating costs of: - The European Bureau for Lesser-Used Languages (EBLUL) and the Mercator information and documentation centres; - European and international organisations committed to preserving Nazi concentration camp sites as historical memorials - Organisation of European cultural interest. The adoption of an EU Council Regulation on the financial regulation applicable to the general budget of the European Communities and the decision to base the structure of the Commission budget on an Activity Based Budgeting (ABB) approach require basic acts to be adopted for a number of grants hitherto financed under appropriations entered in administrative appropriations of the Commission section of the budget. The purpose of this proposal is to adopt an act providing a basis for grants towards the promotion of European cultural networks. It is set to last for a period of five years (2004-2008). The amounts provided for are largely based on those allocated in the budget of the European Union for the 2003 financial year. The total amount proposed is EUR 30.92 million.?

Culture: grants to bodies active at European level, 2004-2006 action programme

The committee adopted the report by Ulpu IIVARI (PES, FIN) amending the proposal under the 1st reading of the codecision procedure. It called for the programme's overall budget for the period 2004-2008 to be increased from EUR 30.92 million to EUR 38.83 million, saying that the financial framework must take the 2004 budget, rather than the 2003 budget, as its starting-point and must incorporate a minimum

increase of 2% for inflation between the 2003 and 2004 budgets. MEPs also deleted the requirement in the Commission's proposal that grants awarded to cultural organisations advancing the idea of Europe be progressively reduced from the third year onwards, arguing that, under the rules on implementing the Financial Regulation, the principle of gradual reduction did not apply to such organisations since they are bodies "pursuing an objective of general European interest". In order for Parliament to be provided with more information about the various activities and organisations being funded, the committee said that it should be able to obtain and analyse at the earliest opportunity the external evaluation which had been commissioned into the organisations concerned. Moreover, the Commission should inform Parliament of the criteria used (priorities, themes and types of activities) before it issued a call for proposals. The Commission was also asked to submit a brief report to Parliament each year on the implementation of the programme. MEPs also adopted an amendment underlying the role of cultural organisations in "promoting awareness of Europe's common cultural heritage". Lastly, in the interests of transparency, they said that any beneficiary of a grant from the EU budget should indicate this in a prominent place such as a website homepage or an annual report.?

Culture: grants to bodies active at European level, 2004-2006 action programme

The European Parliament adopted a resolution drafted by Ulpu IIVARI (PES, FIN) making some amendments to the Commission's proposals. It voted to shorten the programme. Parliament wants it to start on 1 January 2004 and end on 31 December 2006 (instead of ending in December 2008). The budget is therefore reduced from EUR 30.92 million to EUR 22.764 million. Moreover, in order for Parliament to be provided with more information about the various activities and organisations being funded, it should be able to obtain and analyse at the earliest opportunity the external evaluation which had been commissioned into the organisations concerned. The Commission should inform Parliament of the criteria used (priorities, themes and types of activities) before it issued a call for proposals. The Commission is also asked to submit a brief report to Parliament each year on the implementation of the programme. Parliament adopted an amendment underlying the role of cultural organisations in "promoting awareness of Europe's common cultural heritage". In the interests of transparency, the Parliament says that any beneficiary of a grant from the EU budget should indicate this in a prominent place such as a website homepage or an annual report. Parliament also laid down amendments relating to named organisations which may be awarded an operating grant directly and those organisations which receive a grant following a call for proposals in accordance with certain criteria. Finally, the provisions relating to the gradual decrease of grants were deleted. ?

Culture: grants to bodies active at European level, 2004-2006 action programme

The Council's common position, adopted unanimously, accepts 5 of the 15 amendments approved at first reading by the European Parliament. In particular, amendments incorporated in full in the Commission's amended proposal and in the common position concern the following : - provides for an annual report on the implementation of the programme by the Commission; - adds to the list of activities supported that of "cultural ambassador" promoting the common cultural heritage; - adds two evaluation criteria to grant applications (exchange of experiences in promoting cultural diversity, and mobility of arts and artists) and provides for the advertising of grants; - provides for the duration of the future programme to be three years (2004-2006) rather than five years. On the other hand, the Council failed to accept the following amendments: - provides for an amendment to the budget for a period of three years (2004-2006) to 22.764 million euro. - identifies two possibilities for selecting beneficiaries in strand 2 (call for proposals and "earmarking"). With regard to the programme budget over the period 2004-2006, at the budgetary conciliation meeting on 24 November 2003 Parliament, the Council and the Commission agreed on an amount of 19 million euro. This is therefore the amount, already accepted by the Commission, which figures in the common position. On strand 2 of the programme, the Council's common position provides for a system of designated beneficiaries in the annex for 2004, then the establishment of a system of calls for proposals for 2005 and 2006. The agreement reached at the budgetary conciliation meeting provides for an extension of the system of designated beneficiaries in 2005. With regard to the implementing measures and committee procedures, the common position introduces a standard article to clarify the Commission's role in the implementation of the programme. In this connection a reference to annual reporting by the Commission to the Council and the Parliament has also been added. The Council has introduced other modifications or clarifications, as appropriate: - reference to the Council resolution of 19 December 2002 on how European added value of cultural actions can be identified and evaluated; - reference to a requirement to submit a workplan and budget to the Commission; - co-financing requirement was increased to 20 percent under part 1.?

Culture: grants to bodies active at European level, 2004-2006 action programme

The text of the common position is largely acceptable to the Commission, which in particular has accepted, in a spirit of compromise, the reduction in the duration of the programme as requested by Parliament and the Council. The Commission is also in a position to confirm the agreement reached at the budgetary conciliation on 24/11/03 on "earmarking", gradual reduction and clauses derogating from the Financial Regulation. The Commission nevertheless attaches importance to the coherent application of the criteria of Article 2 of the Council Decision on committee procedures (1999/468/EC), the implications of which were highlighted in the judgement of the Court of 21 January. Bearing in mind the budget laid down in the proposal, the criteria of this Article would not be met. Without maintaining its reservation, the Commission therefore presented a unilateral declaration on this subject. Moreover, the Decision should reflect the agreement reached between the co-legislators on 24/11/03, namely: - extension of the system of designated beneficiaries until 2005; - given that the Decision will only be adopted during 2004, inclusion of two derogations from the Financial Regulation worded as follows: "For grants awarded in 2004, it will be possible for the period of eligibility of expenditure to start on 1 January 2004, provided that the expenditure does not precede the date on which the grant application was lodged or the date on which the beneficiary's budget year starts. During 2004, in the case of beneficiaries whose budgetary year starts before 1 March, an exception may be granted to the obligation to sign the grant agreement within the first four months of the start of the beneficiary's budget year, as referred to in Article 112, paragraph 2 of Council Regulation 1605/2002/EC, Euratom on the Financial Regulation applicable to the general budget of the European Communities. In this case, the grant agreement should be signed by 30 June 2004 at the latest". The Commission notes the Council's decision to introduce in Article 6 an appeal to the Management Committee of the Culture 2000 programme relating to various measures for implementing the programme of Community action to promote organisations active at European level in the area of culture.?

Culture: grants to bodies active at European level, 2004-2006 action programme

The committee adopted the report by Ulpu IIVARI (PES, FIN) approving the Council's common position under the 2nd reading of the codecision procedure, subject to a few technical amendments. These were aimed at bringing the agreement reached by the Council of Culture Ministers into line with the agreement reached between Parliament and Council in the course of the budget conciliation (concerning transitional periods for the organisations mentioned in Annex II). The committee also introduced transitional provisions to take account of the fact that the act could not be adopted before the beginning of 2004. In this way, beneficiaries would be able to claim a grant for the totality of their eligible costs in 2004. ?

Culture: grants to bodies active at European level, 2004-2006 action programme

The European Parliament adopted the resolution drafted by Ulpu IIVARI (PES, FIN) and approved the common position subject to a few amendments. (Please see the summary of 19/02/04.) The amendments aim to formalise the agreement reached with the Council during the budget conciliation process on the need for a two year transitional period for the advance earmarking of some of these grants, and to ensure the programme can operate this year, despite the delay in its entry into force, which was scheduled for 1 January 2004.?

The Commission accepts the amendments made by the Parliament, which are designed to make the text consistent with the extension of the budget earmarking system until 2005, and to introduce two derogations from Article 112 (2) of the Financial Regulation¹ so as to take account of the entry into force of this new programme from 2004.?

Culture: grants to bodies active at European level, 2004-2006 action programme

PURPOSE : to establish a Community action programme to promote bodies active at European level in the field of culture. LEGISLATIVE ACT : Decision 792/2004/EC of the European Parliament and of the Council establishing a Community action programme to promote bodies active at European level in the field of culture. CONTENT : based on Article 151 of the EC Treaty, this Decision is intended, following the implementation of the new Financial Regulation applicable to the budget of the European Communities, to establish a basic act for awarding grants to promote organisations active at European level and support specific activities in the area of culture. This programme will cover certain former budget lines in Part A, Chapter 30 of the budget, particularly those aimed at supporting the European Bureau for Lesser Used Languages and Mercator, protecting the sites of Nazi concentration camps as historical monuments, and awarding grants to organisations of European cultural interest. This Decision establishes a Community action programme to promote bodies active at European level in the field of culture. The general objective of the programme is to support the activities of these bodies. The programme covers the following activities: - the ongoing work programme of a body which pursues an aim of general European interest in the field of culture or an objective forming part of the European Union's policy in this area; - a specific action in this area. These activities must contribute, or be capable of contributing, to the development and implementation of Community cooperation policy and actions in the field of culture. The programme shall start on 1 January 2004 and shall end on 31 December 2006. To be eligible for a grant, a body must satisfy the requirements of Annex I and have the following characteristics: - it must be an independent and non-profit-making legal person primarily active in the field of culture, with an objective aimed at the public good; - it must have been legally established for more than two years and have had its annual statement of accounts for the two preceding years certified by a registered auditor; - its activities must be in accordance with the principles underlying Community action in the field of culture and take account of the priorities set out in Annex I. Operating grants for the ongoing work programme of a body pursuing an aim of general European interest in the field of culture or an objective forming part of the European Union's policy in this area shall be awarded in accordance with the overall criteria laid down in Annex I. Grants for actions specified in the programme shall be awarded in accordance with the overall criteria laid down in Annex I. Actions shall be selected by means of a call for proposals. Grants under the different actions of the programme shall be awarded in compliance with the provisions set out in the relevant part of Annex I. The financial framework for the implementation of the programme is hereby set at EUR 19 million. The annual appropriations shall be authorised by the budgetary authority within the limits of the financial perspective. The measures necessary for the implementation of this Decision relating to the matters referred to below shall be adopted in accordance with the management procedure referred to in Article 7(2): - the annual plan of work, including objectives, priorities, the selection criteria and procedures; - the financial support to be supplied by the Community (amounts, duration and recipients) in the areas covered by actions under part 2 and 3 of Annex I, and the general guidelines for implementing the programme; - the annual budget and the breakdown of funds among the different actions of the programme; - the arrangements for monitoring and evaluating the programme and for the dissemination and transfer of results; The measures necessary for the implementation of this Decision relating to all other matters shall be adopted in accordance with the advisory procedure referred to in Article 7(3). The Commission shall be assisted by the Committee provided for in Decision No 508/2000/EC. The Commission shall present to the European Parliament and the Council: - not later than 31 December 2005, a report on the implementation of the programme, on the achievement of its objectives and on a possible future programme to replace the present programme. The Commission shall moreover report to the European Parliament and Council on an annual basis on the implementation of the programme. - not later than 31 December 2007 a report on the achievement of the programme's objectives. This report shall be based, inter alia, on the outcome of the external evaluation and shall assess the results obtained by the beneficiaries of the programme, in particular as regards the effectiveness, efficiency and content of their actions, considered overall and individually, in achieving the objectives set out in Article 1 and in Annex I. ENTRY INTO FORCE : 1 May 2004.?

Culture: grants to bodies active at European level, 2004-2006 action programme

This report has been prepared by the Commission in accordance with provisions set out in Decision No 792/2004/EC and concerns the implementation of the Community's action programme to promote bodies active at a European level in the field of culture. It sets out the

programme's main achievements as well as presenting some of the recommendations proposed by the final external evaluation of the programme.

The main aim of the programme was to strengthen Community intervention in culture by supporting European cultural bodies. In order to prepare the final evaluation Ernst & Young was chosen to carry out the evaluation following an open call for tender. The exercise focused on the period 2004-2006 (the period of the entire programme). In summary, the main findings of the evaluator are as follows:

Effectiveness: The evaluators concluded that drawing general conclusions of the programme's impact on culture was challenging. The programme did, however, promote bodies active at a European level in the field of culture. Objectives were reached largely by supporting networks which helped widen the professionalism of cultural bodies active at a European level. Further, those classified as 'ambassadors' contributed to the promotion of culture in a symbolic manner.

Efficiency: Quantifying the overall efficiency of the programme was challenged by the lack of monitoring data. The evaluators did conclude though that the efficiency of actions varied both between and within the three different parts of the programme. Some beneficiaries and applicants, under part II of the programme, expressed the need for greater transparency in the application process – such as the selection criteria and the composition/appointment of the evaluation committee. Several respondents found that more quantifiable selection criteria would have given the selection process greater legitimacy. Of limited merit only was splitting the beneficiaries into ambassadors, European networks or bodies organising cultural events. An analysis of the activities showed that they were, in fact, very heterogeneous. Projects funded under Part III of the programme, on the other hand managed to produce concrete results, in spite of their small size and limited time frame. In other words, according to the evaluator small grants created concrete products.

Sustainability: Although difficult to generalise, the evaluators nevertheless suggest that projects benefiting from Community funding do last beyond the duration of any given project.

Main Recommendations:

The evaluator gives a set of recommendations for future actions. In short they are:

Effectiveness and efficiency:

- The Commission should strengthen links between the cultural sector and other policies. Structured cooperation with other DGs could be implemented for the monitoring of specific projects.
- The Commission should respect the deadlines for the selection procedure and ensure the publication of applicants' selection earlier.
- The Commission should improve assistance to beneficiaries through publishing a set of guidelines.
- The Commission should develop a data base for monitoring purposes.

Visibility of outputs and results:

- The Commission should introduce specific visibility criteria during the selection process.
- The Commission should prepare a booklet for each beneficiary setting out good practices.

Sustainability:

- The Commission should offer annual as well as multi-annual grants.
- The Commission should strengthen qualitative monitoring during a projects' implementation phase as well as improving resources dedicated to knowledge of the cultural sector.

To conclude, the Commission shares the views expressed by the external evaluators and agrees that the main objectives of the programme have been achieved. Indeed a number of cultural networks and organisations – choirs, museums, orchestras, theatres etc – have received support for the programme to implement activities and projects with a European dimension.
