Car industry: approval of cornering lamps for power-driven vehicles, UN/ECE Regulation

PURPOSE : to enable the EC to vote on a draft Regulation at UNECE on cornering lamps for power driven vehicles. CONTENT : by Council Decision 97/836/EC, the European Community became a Contracting Party to the 1958 Revised Agreement of the United Nations Economic Commission for Europe (UN/ECE). Article 4 of that Decision states that, where a draft Regulation of the United Nations Economic Commission for Europe is submitted to a vote within the UN/ECE, the draft must be approved by the Council, after having received the assent of the European Parliament, before the Community can vote in favour of adopting such a draft Regulation. The provisional agenda for a meeting of the World Forum for Harmonisation of Vehicle Regulations of the UN/ECE includes a vote on a draft (new) Regulation concerning the approval of uniform prescriptions concerning the approval of cornering lamps for power-driven vehicles. The aim of the Regulation is to establish harmonised technical provisions to avoid the creation of technical barriers to trade in motor vehicles between the Contracting Parties, while ensuring a high level of safety and environmental protection. The purpose of the proposal for a Decision is to enable the Commission representative to vote on behalf of the Community on the draft Regulation in question at the forthcoming meeting of the World Forum for Harmonisation of Vehicle Regulations of the United Nations Economic Commission for Europe.?
