European Union Solidarity Fund: mobilisation for the fire related disaster in Portugal, budget 2003

PURPOSE : to mobilise the European Union Solidarity Fund, in order to assist Portugal in the wake of the fires in 2003. **CONTENT :** the Commission proposes the sum of EUR 31.655 million for fire-related emergency measures in Portugal, in response to Portugal's application for aid. This money will be used for reimbursing the cost of emergency measures such as rescue services, providing for temporary accommodation, energy and water and repairing basic infrastructure. The damages were caused by a large number of fires which started on 20 July and which have claimed 18 lives to date. It is estimated that 270,000 hectares of forest and 25,000 hectares of agricultural land have been destroyed. The disaster is reported to have caused the loss of goods, jobs and employment for about 45,000 persons. This is the first "major disaster" requiring intervention by the Solidarity Fund this year. Payment from the fund will flow immediately after the approval by the Council and the European Parliament expected before mid-October and following the signature of the Portuguese Government and the European Commission. To enable a quick decision by Council and Parliament, the Commission has also adopted the corresponding proposal to mobilise the Solidarity Fund and a Provisional Draft Amending Budget (see BUD/2003/2144). The latter request does not cover payment appropriations, as the sum necessary can be found by redeployment within the sums already budgeted. The EUSF is not designed to pay for the whole of the damages but only for costs related to emergency measures. **CALCULATION METHOD:** The total damage caused by the fires is estimated at about EUR 1 billion. The amount of direct damage reaches EUR 946.5 million (0,864% of the Portuguese GNI) and the amount of EUSF eligible emergency measures is EUR 79.6 million. The proposed EUSF contribution amounts to 40% of the eligible emergency measures. Its calculation method is as follows: 2.5% of the direct damages up to 0.6% of the GNI (i.e. EUR 17.953 million) and 6% of the damages above this level (i.e. EUR 13.702 million).?

The committee adopted the report by Joan COLOM i NAVAL (PES, E) approving the proposals to mobilise the EU Solidarity Fund to help cover the cost of damage caused by the sinking of the 'Prestige' oil tanker off the coast of Spain, an earthquake and the eruption of Mount Etna in Italy and forest fires in Portugal. The report called on the Commission to present "a concise quantitative and qualitative assessment of the initial instances of Fund intervention, and particularly the implementation criteria", so that Parliament could evaluate the Fund's operation. It noted that the damage caused by the natural disasters could have been wholly or partly prevented and "should give incentives for the development and implementation of prevention policies and adequate legislation on conservation and appropriate land use". As regards the proposal on the disasters in Spain and Italy, MEPs wanted the Commission to explain the long presentation deadlines for certain requests for assistance and asked whether these were due to excessively complex provisions in the Fund's regulations or to poor coordination between national and Community administrations. As regards the proposal concerning the fires in Portugal, the Commission was asked to report on the use of existing Community subsidies for the protection of the Community's woodlands, while the Council was asked to agree to the European Parliament's demands concerning the Forest-Focus programme currently going through the conciliation process.?

PURPOSE : to mobilise the European Union Solidarity Fund, in order to assist Portugal in the wake of the fires in 2003. **LEGISLATIVE ACT :** Decision 2003/786/EC of the European Parliament and of the Council on the mobilisation of the EU Solidarity Fund in accordance with point 3 of the Interinstitutional Agreement of 7 November 2002 between the European Parliament, the Council and the Commission on the financing of the European Union Solidarity Fund, supplementing the Interinstitutional Agreement of 6 May 1999 on budgetary discipline and improvement

of the budgetary procedure (fires in Portugal). CONTENT : the European Union has created a European Union Solidarity Fund to show solidarity with the population of regions struck by disasters. Portugal submitted an application to mobilise the Fund on 13 August 2003, concerning a fire-related disaster. The Interinstitutional Agreement of 7 November 2002 allows the mobilisation of the Fund within the annual ceiling of EUR 1 billion. The fire-related disaster in Portugal meets the conditions for mobilising the Fund. This Decision stipulates that for the general budget of the European Union for the financial year 2003, the European Union Solidarity Fund shall be mobilised to provide the sum of EUR 48,539 million in commitment appropriations. ENTRY INTO FORCE : 9 October 2003.?
