Europol: adjusting the basic salaries and allowances as from july 2002. Initiative Ireland

PURPOSE : to adopt a Council Decision adjusting the basic salaries and allowances applicable to Europol staff. PROPOSED ACT : Council Decision (Initiative of Ireland). CONTENT : this draft initiative aims to adjust the basic salaries and allowances applicable to the Europol staff. In light of the review of officials of Europol by the Management Board which took account of the changes in the cost of living in the Netherlands, as well as of the changes in salaries in the public service in the Member States and in accordance with Council Decision of 5 June 2003 adjusting the remuneration of officials as from 1 July 2002 (CNS/2003/0806) was unable to take correct account of the trend in the net remuneration of French civil servants and a correction of the trend in the changes in the cost of living in the Netherlands, the said review justifies an increase of 0,9 % of remuneration for the period between 1 July 2001 and 1 July 2002. It is for the Council, acting unanimously, to adjust the basic salaries and allowances of officials of Europol, on the basis of the review.?

The committee adopted the report by Maurizio TURCO (Ind, I) rejecting the Irish initiative. MEPs felt that the proposal should be assessed in the more general context of the latest developments concerning Europol, in particular the question of whether or not Parliament's repeated requests on the requisite judicial and democratic control of Europol and on data protection and access to documents were being heeded by the Council. They concluded that Parliament continued to have no real powers of scrutiny or budgetary powers following the adoption of the Protocol to the Europol Convention in November 2003, and that Europol was continuing to amass powers and operating capabilities which escaped all democratic and jurisdictional control at both national and European levels. For this reason, the committee proposed that Parliament reject the initiative on which it was being consulted.?

The European Parliament rejected by 54 votes in favour, 411 against and 43 abstentions three initiatives of Ireland for Council Decisions adjusting the Europol staff regulations and basic salaries. PURPOSE : toincrease the basic salaries and allowances applicable to Europol staff.

LEGISLATIVE ACT : Council Decision 2004/C 114/04 adjusting the basic salaries and allowances applicable to Europol Staff.

CONTENT : A remuneration review took account of the changes in the cost of living in the Netherlands, as well as of the changes in salaries in

the public service in the Member States. The Council Decision of 5 June 2003 adjusting the remuneration of officials as from 1 July 2002 was unable to take correct account of the trend in the net remuneration of French civil servants and a correction of the trend in the changes in the cost of living in the Netherlands. The review justifies an increase of 0.9 % of remuneration for the period between 1 July 2001 and 1 July 2002.

This Decision accordingly adjusts the basic salaries and allowances of officials of Europol, on the basis of the review.
