### Amending budget 2/2004: section VIII part B: European data-protection Supervisor

PURPOSE: to present the Preliminary Draft Amending Budget (PDAB) No 1 to the budget for 2004. General statement of revenue and expenditure by section - Section VIII Part B: European Data-protection Supervisor. CONTENT: this proposal provides appropriations for the budget lines in Section VIII Part B of the 2004 budget to finance the European Data-protection Supervisor. This budgetary framework for the European Data-protection Supervisor has mainly been based on the budget allocations for the European Ombudsman, an institution which is comparable as regards its size and as its type. This amending budget contains a total of EUR 1 272 000 in expenditure and EUR 90 000 in revenue. It also proposes the entry of 15 posts in the establishment plan of Section VIII Part B. This proposal is identical to the budget adopted in 2002 for Section VIII Part B in terms of expenditure and the establishment plan. It is slightly different in terms of revenue to take account of the impact of the transitional reform measures on revenue. The Supervisor has now been appointed and it is important that his budget be allocated the amount he needs to start his duties. As he has been appointed only recently and there is no practical possibility of him presenting an amending budget in such a short term, the Commission proposes that the appropriations and establishment plan approved by the budgetary authority in the 2002 budget be entered in Section VIII Part B. The Supervisor himself could present another amending budget in the course of 2004 to fine-tune the budget and/or establishment plan in Section VIII Part B.?

#### Amending budget 2/2004: section VIII part B: European data-protection Supervisor

The committee adopted the report by Neena GILL (PES, UK) approving Draft Amending Budget No. 2/2004 unamended on the grounds that it provided sufficient funding for the European Data-Protection Supervisor whilst staying within the ceiling of Heading 5 of the financial perspective and not restricting other activities. MEPs also called for the European Data-Protection Supervisor to submit a report before September 2004 (in time for the start of the 2005 budgetary procedure) assessing operational needs, the progress made in setting up administrative structures and recruitment procedures, the cooperation agreement with Parliament and financial and budgetary management.?

#### Amending budget 2/2004: section VIII part B: European data-protection Supervisor

On 26 February 2004 the Council established draft amending budget No 2 for the financial year 2004, by adopting the preliminary draft amending budget without amendment (please see resume of 3 February 2004). Under draft amending budget No 2 for the financial year 2004, total expenditure stands at EUR 111 301 527 149 in commitment appropriations and EUR 99 725 658 671 in payment appropriations.?

## Amending budget 2/2004: section VIII part B: European data-protection Supervisor

PURPOSE: final adoption of the amending budget 2/2004 of the European Union. LEGISLATIVE ACT: 2004/347/EC, Euratom. CONTENT: the European Parliament adopted the amending budget 2/2002 of the European Union in accordance with its resolution of 9 March 2004 (refer to the summary of this resolution). This amending budget provides appropriations for the budget lines in Section VIII Part B of the 2004 budget

to finance the European Data-protection Supervisor. A total amount of EUR 1 272 000 has been allocated as well as the creation of 15 posts in the establishment plan of Section VIII Part B of the 2004 budget.?

## Amending budget 2/2004: section VIII part B: European data-protection Supervisor

By adopting the report by Neena GILL (PES, UK), the European Parliament approved the Draft Amending Budget 2/2004. Parliament considers that the Draft Amending Budget 2/2004, as established by the Council, provides sufficient appropriations for the European Data Protection Supervisor for the year 2004 for him to begin his duties. It requests the European Data Protection Supervisor to submit a report to the Budgetary Authority before 30 September 2004, with a view to Parliament's first reading of the 2005 budget, assessing the state of play as regards operational needs, the progress made in setting up the administrative structures and recruitment procedures, the co-operation agreement with the European Parliament, and financial and budgetary management. Lastly it considers that the Draft Amending Budget 2/2004 is compatible with the ceiling fixed in heading 5 of the financial perspective without restricting other activities.?
