European Central Bank (ECB): appointing a Member of the Executive Board

PURPOSE : to appoint a member of the Executive Board of the European Central Bank. CONTENT : this recommendation calls for Mr José Manuel GONZALEZ-PARAMO be appointed a member of the Executive Board of the European Central Bank for a term of office of eight years with effect from 1 June 2004. This Recommendation shall be submitted for a decision to the Heads of State or Government of the Member States of the European Community whose currency is the euro, after consulting the European Parliament and the Governing Council of the European Central Bank.?

European Central Bank (ECB): appointing a Member of the Executive Board

The Governing Council of the ECB adopted an opinion on a recommendation from the Council of the European Union on the appointment of a new member of the Executive Board of the ECB. The Governing Council had no objections to the proposed candidate, Mr José Manuel Gonzalez-Paramo, who is a person of recognised standing and professional experience in monetary or banking matters, as required by Article 112 (2) (b) of the Treaty establishing the European Community. Following this ECB opinion and an opinion of the European Parliament, the new member of the Executive Board will be appointed by common accord of the governments of the Member States which have adopted the single currency at the level of Heads of State or Government.?

The committee adopted the report by its chair, Christa RANDZIO-PLATH (PES, D), recommending that Parliament endorse the appointment of José Manuel GONZÁLEZ PÁRAMO as a member of the Executive Board of the European Central Bank to replace Eugenio DOMINGO SOLANS, who would be stepping down at the end of May 2004. ?

European Central Bank (ECB): appointing a Member of the Executive Board

PURPOSE : to appoint a Member of the Executive Board of the European Central Bank. LEGISLATIVE ACT : Decision 2004/488/EC taken by common accord, at the level of heads of state or government, by the governments of the Member States having the EURO as their currency.

CONTENT : with this present Decision, Mr José Manuel GONZALEZ-PARAMO is appointed a Member of the Executive Board of the European Central Bank for a term of office of eight years as from 1 June 2004.?
