## EC/Egypt Euro-Mediterranean Association Agreement: protocol to take in account the accession of the new countries in 2004

This document comprises of the definitive protocol to the Agreement between the European Union and Egypt on the 10 new Member States adhering to the Euro-Mediterranean Agreement between it and the EU.

## EC/Egypt Euro-Mediterranean Association Agreement: protocol to take in account the accession of the new countries in 2004

PURPOSE : to enable the 10 New Member States to adhere to the Euro-Mediterranean Agreement between the European Communities and Egypt.

PROPOSED ACT : Council Decision.

CONTENT : in accordance with Article 6(2) of the Treaty of Accession of the new Member States to the European Union, the accession of these new Member States to the Euro-Mediterranean Agreement between the EU and Egypt should be approved by the conclusion of protocol to this Agreement. This is the aim of this proposal. The text of the Protocol negotiated with Egypt is attached to this decision.

By adopting the report by Elmar BROK (EPP-ED, Germany), the European Parliament gave its assent to the conclusion of a Protocol to the Euro-Med Agreement between the EC and Egypt.

PURPOSE: to include the 10 new Member States in the Euro-Mediterranean Agreement with Egypt.

LEGISLATIVE ACT: Council Decision 2005/702/EC concerning the conclusion of a Protocol to the Euro-Mediterranean Agreement between the European Communities and their Member States, on the one hand, and the Arab Republic of Egypt, on the other, to take account of the accession of the 10 new Member States to the European Union.

CONTENT: this Decision adopts the protocol negotiated with Egypt. The most important aspects of the protocol are provision for the accession of the new Member States to the EU-Egypt Association Agreement, adaptation of the Protocol on agricultural products and inclusion of the new official languages of the EU.

ENTRY INTO FORCE: 1 October 2005.
