The European Parliament confirmed as its first reading the text voted on 12.02.1992 on the proposal for a Directive onwheeled agricultural or forestry tractors the number of the legal base of which changed with the entry into force of the Amsterdam Treaty. It should be noted that this proposal was already the subject of a confirmation of opinion given on 02.12.1993 following the entry into force of the Treaty of Maastricht on European Union.?
