## EC/Chile Association Agreement: 2004 enlargement of the EU. Protocol

This document comprises of the definitive protocol to the Agreement between the European Union and Chile on the 10 new Member States adhering to the Association Agreement between it and the EU.

The committee adopted the report by its chairman, Enrique BARÓN CRESPO (PES, ES), recommending that Parliament give its assent to the conclusion of the protocol to the agreement.

## EC/Chile Association Agreement: 2004 enlargement of the EU. Protocol

PURPOSE : to enable the 10 New Member States to adhere to the Association Agreement between the European Communities and Chile.

PROPOSED ACT : Council Decision.

CONTENT : in accordance with Article 6(2) of the Treaty of Accession of the new Member States to the European Union, the accession of these new Member States to the Association Agreement between the EU and Chile should be approved by the conclusion of an additional

protocol to this Agreement. This is the aim of this proposal. The text of the Protocol negotiated with Chile is attached to this decision.

**PURPOSE:** the conclusion of an Additional Protocol to the Agreement establishing an association between the European Community and its Member States, of the one part, and the Republic of Chile, of the other part, allowing the 10 New Member States to adhere to the Association Agreement.

**LEGISLATIVE ACT:** Council Decision 2005/423/EC.

**CONTENT:** The most important aspects of the protocol are the provisions for the accession of the new Member States to the EU-Chile Association Agreement and the inclusion of the new official languages of the EU.
