Court of Auditors: appointment of M. Kikis Kazamias

PURPOSE: to nominate Mr. KAZAMIAS as a Member of the Court of Auditors.

CONTENT: with this proposal, the Secretary General of the Council of the European Union proposes to appoint Mr. KAZAMIAS as a Member of the Court of Auditors.

The committee adopted the report by Szabolcs FAZAKAS (PES, HU) approving the appointment of Mr Kikis KAZAMIAS as a Member of the Court of Auditors (consultation procedure).

Court of Auditors: appointment of M. Kikis Kazamias

The European Parliament adopted a resolution by Szabolcs FAZAKAS (PES, HU) delivering a favourable opinion on the appointment of Kikis Kazamias as a Member of the Court of Auditors. The resolution was adopted by 435 in favour to 39 against with 36 abstentions in a secret ballot. Nine members from the new Member States were appointed in May 2004, but the then Cypriot candidate withdrew after a negative opinion from Parliament.
