EIB loans to PECO, Western Balkans, Mediterranean countries, Latin America, Asia and South Africa: Community guarantee. Codification

PURPOSE : to grant a Community guarantee to the European Investment Bank against losses under loans for projects outside the Community (Central and Eastern Europe, Mediterranean countries, Latin America and Asia and the Republic of South Africa).

PROPOSED ACT : Council Decision.

CONTENT : the purpose of this proposal is to undertake a codification of Council Decision 2000/24/EC of 22 December 1999 granting a Community guarantee to the European Investment Bank against losses under loans for projects outside the Community (Central and Eastern Europe, Mediterranean countries, Latin America and Asia and the Republic of South Africa). The new Decision will supersede the various acts incorporated in it; this proposal fully preserves the content of the acts being codified and hence does no more than bring them together with only such formal amendments as are required by the codification exercise itself.

The committee adopted the report by Diana WALLIS (ALDE, UK) approving unamended - under the consultation procedure - the proposed

decision granting a Community guarantee to the European Investment Bank against losses under loans for projects outside the Community (Central and Eastern Europe, Mediterranean countries, Latin America and Asia and the Republic of South Africa) (codified version).

The European Parliament adopted the resolution drafted by Diana WALLIS (ALDE, UK) and approved the proposed decision granting a Community guarantee to the European Investment Bank against losses under loans for projects outside the Community (Central and Eastern Europe, Mediterranean countries, Latin America and Asia and the Republic of South Africa) (codified version). The resolution was adopted by 645 votes in favour to 17 against.

PURPOSE: to grant a Community guarantee to the European Investment Bank against losses under loans for projects outside the Community.

LEGISLATIVE ACT: Council Decision 2008/580/EC granting a Community guarantee to the European Investment Bank against losses under loans for projects outside the Community (South-eastern neighbours, Mediterranean countries, Latin America and Asia and the Republic of South Africa) (Codified version).

CONTENT: this Decision codifies Council Decision 2000/24/EC granting a Community guarantee to the European Investment Bank against losses under loans for projects outside the Community (Central and Eastern Europe, Mediterranean countries, Latin America and Asia and the Republic of South Africa). The new Decision will supersede the various acts incorporated in it; this proposal fully preserves the content of the acts being codified and hence does no more than bring them together with only such formal amendments as are required by the codification exercise itself.
