Wheeled agricultural or forestry tractors: field of vision and windscreen wipers (repeal. Directive 74/347/EEC). Codification

PURPOSE: to codify provisions in the field of vision and windscreen wipers for wheeled agricultural or forestry tractors.

PROPOSED ACT: Directive of the European Parliament and of the Council.

CONTENT: the purpose of this proposal is to codify EU provisions in the field of vision and windscreen wipers for wheeled agricultural or forestry tractors, as set out in Directive 74/347/EEC. In codifying acts that have been amended frequently the EU is seeking to both simplify and clarify EU legislation.

Given that no changes of substance have been made to the instruments affected by the codification exercise this proposal will be the subject of an accelerated procedure. The new Directive will supersede the various acts incorporated in it. It fully preserves the content of the acts being codified and hence does no more than bring them together, with only such formal amendments as are required by the codification exercise itself.

The committee adopted the report by Diana WALLIS (ALDE, UK) approving unamended - under the 1st reading of the codecision procedure - the proposed directive on the field of vision and windscreen wipers for wheeled agricultural or forestry tractors (codified version).

The European Parliament adopted the resolution drafted by Diana WALLIS (ALDE, UK) and approved the proposed directive on the field of vision and windscreen wipers for wheeled agricultural or forestry tractors (codified version).

PURPOSE: codification of Directive 74/347/EEC on the approximation of the laws of the Member States relating to the field of vision and windscreen wipers for wheeled agricultural or forestry tractors.

LEGISLATIVE ACT: Directive 2008/2/EC of the European Parliament and of the Council relating to the field of vision and windscreen wipers for wheeled agricultural or forestry tractors (codified version).

CONTENT: the aim of this Directive is to codify Council Directive 74/347/EEC of 25 June 1974 on the approximation of the laws of the Member States relating to the field of vision and windscreen wipers for wheeled agricultural or forestry tractors. The new Directive supersedes the various acts incorporated in it; it fully preserves the content of the acts being codified and hence does no more than bring them together with only such formal amendments as are required by the codification exercise itself.

ENTRY INTO FORCE: 18/02/2008.

APPLICATION: from 01/05/2008.
