## Identification and registration of pigs (repeal. Directive 92/102/EEC). Codification

**PURPOSE:** to undertake a codification of Council Directive 92/102/EEC of 27 November 1992 on the identification and registration of animals.

**PROPOSED ACT:** Council Directive.

**Content:** The purpose of this proposal is to undertake a codification of Council Directive 92/102/EEC of 27 November 1992 on the identification and registration of animals. The new Directive will supersede the various acts incorporated in it. This proposal fully preserves the content of the acts being codified and hence does no more than bring them together with only such formal amendments as are required by the codification exercise itself.

## Identification and registration of pigs (repeal. Directive 92/102/EEC). Codification

The Committee on Legal Affairs adopted the report by Lidia Joanna GERINGER DE OEDENBERG (PES, PL) approving, under the consultation procedure, the proposal for a Council directive on the identification and registration of pigs (codified version).

Although no formal amendments were made to the proposal, the committee took note of the recommendations of the Consultative Working Party of the legal services of the European Parliament, Council and Commission, which made a number of technical comments on the text of the codified proposal.

The only change made by the Consultative Working Party concerned Article 4(2)(b), second subparagraph of the proposal: the expression 'paragraph 1' was adapted so as to read 'paragraph 1, third subparagraph'.

Excluding this element, the proposal represents a pure and simple codification of existing texts, without amendments to their substance.

## Identification and registration of pigs (repeal. Directive 92/102/EEC). Codification

The European Parliament adopted, by 598 to 9 with 18 abstentions, a legislative resolution under the consultation procedure approving the

proposal for a Council directive on the identification and registration of pigs (codified version).

The report was tabled for plenary by Lidia Joanna GERINGER DE OEDENBERG (PES, PL) on behalf of the Committee on Legal Affairs.

The proposal was approved as adapted to the recommendations of the Consultative Working Party of the Legal Services of the European Parliament, the Council and the Commission.
