Pressure equipment: simple pressure vessels. Codification

PURPOSE: codification of the Directive on the harmonisation of the laws of the Member States relating to simple pressure vessels.

PROPOSED ACT: Directive of the European Parliament and of the Council.

CONTENT: the purpose of this proposal is to undertake a codification of Council Directive 87/404/EEC of 25 June 1987 on the harmonisation of the laws of the Member States relating to simple pressure vessels. The new Directive will supersede the various acts incorporated in it. This proposal fully preserves the content of the acts being codified and hence does no more than bring them together with only such formal amendments as are required by the codification exercise itself.

Pressure equipment: simple pressure vessels. Codification

The Legal Affairs Committee adopted a report drafted by Diana WALLIS (ALDE, UK) and approved the proposal on the codification of Council Directive 87/404/EEC on the harmonisation of the laws of the Member States relating to simple pressure vessels. The Commission's proposal was approved as adapted to the recommendations of the Consultative Working Party of the Legal Services of the European Parliament, the Council and the Commission.

The European Parliament adopted, by 651 votes to 17 with 9 abstentions, under 1st reading of the codecision procedure, a legislative resolution approving the proposal for a directive of the European Parliament and of the Council relating to simple pressure vessels (codified version). The report had been tabled for consideration in plenary by Diana WALLIS (ALDE, UK) on behalf of the Legal Affairs Committee. The Commission proposal was approved as adapted to the recommendations of the Consultative Working Party of the Legal Services of the European Parliament, the Council and the Commission.
