### Goods resulting from the processing of agricultural products: trade arrangements. Codification

PURPOSE: to codify legislation on trade arrangements applicable to certain goods resulting from the processing of agricultural products.

PROPOSED ACT: Council Regulation.

CONTENT: the purpose of this proposal is to undertake a codification of Council Regulation (EC) No 3448/93 of 6 December 1993 laying down the trade arrangements applicable to certain goods resulting from the processing of agricultural products. The new Regulation will supersede the various acts incorporated in it. This proposal fully preserves the content of the acts being codified and hence does no more than bringing them together with only such formal amendments as are required by the codification exercise itself.

The Committee on Legal Affairs adopted the report drawn up by Lidia Joanna GERINGER de OEDENBERG (PES, PL) approving, under the consultation procedure, the proposal for a Council Regulation laying down the trade arrangements applicable to certain goods resulting from the processing of agricultural products (codified version).

The Commission proposal was approved as adapted to the recommendations of the Consultative Working Party of the legal services of the European Parliament, the Council and the Commission.

The European Parliament adopted by 632 votes to 13, with 18 abstentions, a legislative resolution, approving, under the consultation procedure, the proposal for a Council Regulation laying down the trade arrangements applicable to certain goods resulting from the processing of agricultural products (codified version).
